## Statement to Alameda City Council on 3/3/2015 regarding Agenda Item 3A – February 10, 2015 Fuel Spill on the Oakland Estuary

At approximately 9:00pm on Tuesday, February 10, 2015 I received a call from AJ MacLaren, the C&C Security guard at the marina, saying that there was a major fuel spill at the marina and I needed to get there as quickly as possible. I arrived at the marina at about 9:10pm and short time later two trucks from the Alameda Fire Department arrived at the marina.

The AFD personnel and I proceeded to the marina docks and it immediately became apparent that a major spill was underway. The fumes on the docks were intense, and became stronger further from shore towards the estuary. When we shined our flashlights out into the open estuary, the sheen was visible as far as we could see. Close examination indicated a clear fluid and the smell was similar to kerosene. AJ MacLaren, the marina security guard who is a Gulf War veteran said that he thought the spilled material was JP-5, an aviation fuel.

I told Captain Richterman of AFD, the commanding officer on scene, that I would go to the marina office and make a spill report to both the USCG National Response Center (Report # 1107844 at 9:28pm PST) and the California Office of Emergency Services (Report 15-0843 at 9:36pm PST). I then called Coast Guard Sector San Francisco and told them that there was a major fuel spill on the estuary and that they needed to get personnel here as quickly as possible. I was told that the team they had to conduct spill investigations was currently at an oil spill at the Shell refinery in Martinez. I then returned to the docks for a more thorough investigation. It was at that time that AJ MacLaren and I contacted our liveaboard tenants and told them that given the magnitude of the spill and the intensity of the fuel vapors, we didn't think it was a good idea for them to spend the night on their boats. Some of our tenants left to stay at local motels while others slept in their cars in the parking lot. I returned to the office and again called the National Response Center and Cal OES and gave them an update saying that the spill was significant (10:42pm). I left the marina around midnight with an extreme headache from the fumes which lasted much of the following day.

I returned to work at 8:00am the following morning, Wednesday, February 11<sup>th</sup>, and was alarmed to find that there had been no on-site response by any agency by that time. I again called the National Response Center, Cal OES (update 8:17am), and Coast Guard Sector San

Around 9:00am personnel from both the US Coast Guard and the California Department of Fish & Wildlife arrived at the marina and began taking samples. TV news crews from NBC and the local ABC affiliate (KGO-Channel 7)

http://abc7news.com/news/crews-work-to-cleanup-oil-spill-in-oakland-estuary-/514031/ also arrived at the marina. While down on the docks I received a call on my cell phone from Alex Emslie, a reporter for KQED news. He wanted to know about the oil spill on the estuary. I told him that it wasn't the black thick oil that most people think of in an oil spill, but rather a much more refined petroleum product. I then passed the phone to Dave Irwin from the US Coast Guard. Alex pressed Dave on what he thought the source of the spill was and he responded that the USCG cutters across the estuary from the marina were suspect. Between 11:00am-noon a hazardous waste cleanup crew from the NRC Corporation arrived at the marina. They deployed a floating containment boom around our Pier 2 which has the covered berths at the marina. The crew then dispensed white absorbent pads in the worst areas of contamination to soak up as much material as possible. An attached file shows this activity. It is important to note that some of the bags of hazardous waste the pads have largely retained their white color. This would be characteristic of a kerosene-like material. Other bags show waste pads with a distinct red color which is consistent with marine diesel which contains a red dye.

At 3:00pm on Friday, March 13 the aforementioned KQED news article was updated with a new headline, "State: Coast Guard Not the Source of Oakland Estuary Mystery Spill". The article states, "Lab tests conducted by the state Department of Fish and Wildlife Office of Spill Prevention and Response have concluded that Coast Guard vessels in the Oakland Estuary were not the cause of what officials are calling a "mystery sheen" of diesel fuel that appeared near the Alameda Marina late Tuesday night. "The amount of diesel that was spilled most likely didn't come from one boat at the marina," OSPR spokesman Eric Laughlin said.


To my knowledge there was no written release of this conclusion, with associated laboratory data, to the City of Alameda, any impacted marinas, or any other news outlet. In my opinion, it seems highly unusual that a definitive finding on a source of a hazardous spill event this large would be provided by the US Coast Guard to one, and only one, reporter.

On Sunday, February 15<sup>th</sup> I took pictures of an illegal anchor-out compound along the Oakland shoreline just east of the Union Point Marina (photo attached). Amongst the floating docks and derelict vessels there were numerous fuel tanks and a large drum on its side. I emailed these photos to USCG Captain Gregory Stump and encouraged them to investigate this site.

On Wednesday, February 18<sup>th</sup> I received a call back from LCDR Rhianna Macon, Incident Management Division Chief Sector San Francisco. She assured me that the Coast Guard had visited this anchor-out compound on Sunday, February 15<sup>th</sup> and concluded that this site was not involved with the spill. When I asked her what was found in the spill she told me that it was a mix of both diesel and JP-5. I said that this was an interesting confirmation of what a number of my tenants had told me, and as far as I knew, only the Coast Guard would be a likely source of JP-5 on this on this part of the Oakland Estuary. Later that day at 5:46pm I received an email from LCDR Macon stating, "I wanted to inform you that I misspoke earlier regarding the product which was spilled, it was only marine diesel spilled and not JP-5. A sample of JP-5 was taken from one of the CG Cutters at Coast Guard Island but it was ruled out in an independent analysis. My apologies for this misinformation."

Given the magnitude of this spill, which ultimately stretched for several miles along the estuary, with the associated risks to health and safety, it is important that the public know all of the facts.









## Update on the fuel spill in the Oakland Estuary, near Alameda Marina

According to the United States Coast Guard, the clean-up efforts concluded Thursday, February 12, 2015. The source of the spill and amount of product has yet to be determined. The Coast Guard and California Department of Fish and Wildlife are investigating the incident.

On Tuesday, February 10, 2015, at 9:12 P.M., Alameda Fire was requested by the US Coast Guard to investigate the report of a possible spill in the Oakland Estuary near the Alameda Marina. AFD responded to the scene and confirmed a diesel fuel-like smell and a sheen floating on the water. They were unable to determine the source of the product, or the scale of involvement in the Estuary. The Coast Guard was updated of these findings by the AFD Battalion Chief.

As required for Hazardous Materials Incidents, notifications were immediately made by AFD to the National Response Center, United States Environmental Protection Agency, California Office of Emergency Services, California Department of Fish and Wildlife, Alameda County Environmental Health and Alameda Police.

The Coast Guard advised AFD they would respond at daylight to further assess the incident.

On Wednesday morning the Coast Guard commenced its clean-up and investigation.





### **Poaching**

Poaching is the illegal taking of fish and wildlife. It can involve hunting out of season, the taking of more fish or game animals than the law allows, and the illegal commercialization of species including abalone, sturgeon, bears, reptiles and many others. Equally devastating crimes include pollution and habitat destruction and the insidious practice of transporting and introducing non-native, undesirable fish (like northern pike and white bass) into California's lakes and rivers.

Although deer are a frequently poached animal, virtually all other species of California wildlife are also subject to illegal activity including bear, elk, antelope, marine fish, crustaceans, abalone and other mollusks, inland fish, raptors, and reptiles.

Poachers devastate nature by breaking laws designed to assure proper wildlife management and species survival. Poaching is an insult to the vast majority of hunters and anglers who obey the rules.

Because poaching is a crime of secrecy and stealth, its full impact in California is impossible to fully gauge. However, enough poaching is documented to realize that it exacts a very heavy toll.

State Department of Fish and Game wardens do all they can to combat poaching. But there are only a few hundred wardens spread throughout California. To successfully fight poaching they must have help from all Californians.



## CalTP

## A Confidential Secret Witness Program

CalTIP (Californians Turn In Poachers and Polluters) is a confidential secret witness program that encourages the public to provide Fish and Game with factual information leading to the arrest of poachers and polluters.

CalTIP was introduced in California in 1981 in order to give Californians an opportunity to help protect the state's fish and wildlife resources. The toll free telephone number operates 24 hours a day, 7 days a week. You do not have to give your name.



#### **Pollution**

As the population of California swells, the effects of pollution are felt more profoundly than ever.

Incidents of industrial and agricultural pollution as well as the dumping of household waste can be devastating to our fish and wildlife and the habitat on which they depend.

To combat polluting, concerned citizens who become aware of such acts can become involved and report their observations.

## To Report a Poacher or Polluter


If you witness a poaching or polluting incident or any fish and wildlife violation, or have information about such a violation, immediately dial the toll free CalTIP number

**1 888 DFG-CALTIP** (888 334-2258), 24 hours a day, seven days a week.

Be prepared to give the fullest possible account of the incident including the name, address, age and description of the suspect, vehicle description, direction of travel, license number, type of violation and when and where it occurred. You do not have to give your name.

Information from the call is relayed to the Fish and Game region where the offense occurred and an investigation is undertaken locally. If the information supplied by the caller results in an arrest the caller becomes eligible for a reward. (Rewards up to \$1,000 have been paid.) The case is then reviewed by a volunteer citizen's group known as the "Caltip Citizens Review Board".

CalTIP rewards come entirely from donations, no state funds are used. The CalTIP Citizen's Review Board, not the Department of Fish and Game receives and administers these funds. Money not used for the payment of rewards goes toward furthering CalTIP's educational goals (public service announcements, informational videos, billboard campaigns, etc.).





Sturgeon are sometimes illegally taken for their eggs (roe) and sold for commercial purposes.



California's abalone is a prime target. This delicacy is targeted by poachers for the high price per pound it brings on the black market. Roadside checkpoints help to keep people honest and aware of the size limits.



More than 450 abalone were stripped from California's north coast by 2 poachers who hid their catch in the hold of this boat.
