NOTICE of:

Restoration and Addition of Bus Stops along Atlantic Avenue, Buena Vista Avenue and Broadway for AC Transit's Line 19, and Public Hearing on Wednesday, May 25, 2016

Dear Alameda Resident, Business/Property Owner or Employee:

AC Transit is introducing a new Line 19, using parts of the former Line 19, through Alameda. The new line will provide bus transit service between Fruitvale and 12th Street BART Stations via Alameda along Webster Street, Atlantic Avenue, Buena Vista Avenue, Broadway, Blanding Avenue and Tilden Way. In preparation for the start of service later this year, City staff is recommending that the Transportation Commission approve new and restored bus stop locations on Wednesday, May 25 at 7 p.m. (City Hall, City Council Chambers, 2263 Santa Clara Avenue).

The City and AC Transit **invite your comments, by May 11**th, on the proposed *preliminary* list of new Line 19 bus stop locations, changes, and improvements, shown in Attachment A. The proposed bus stops are primarily at locations where the old Line 19 previously stopped. The project will include installing new bus stop poles with bus stop signage; repainting and/or extending red curbs to accommodate buses, which could remove some parking spaces; and expanding sidewalks to provide better access for pedestrians and comply with the Americans with Disabilities Act.

The Public Works Department requests that comments be submitted by Wednesday, May 11th, 2016 at 6:00 p.m., so that they may be reviewed and considered in advance of the Transportation Commission meeting. All comments will be part of the official public record.

A *recommended* list of bus stops will be developed for consideration by the City's Transportation Commission at their May 25th meeting. This recommended list may be slightly different from the one presented in Attachment A, to reflect submitted public comments and additional field

review. The full staff report will be posted to the project web page (www.alamedaca.gov/public-works/line-19) and also to https://alameda.legistar.com/Calendar.aspx by May 17th, and will include a recommended list of stops, final number of parking spaces to be removed, and a summary of all submitted public comments.

The Commission will make a recommendation on the *recommended* bus stop locations and proposed changes and improvements, which staff will then implement. You are invited to attend this public hearing:

Background on Line 19:

In 2015, AC Transit developed a district-wide Service Expansion Plan (SEP) amounting to \$25.4 million annually. The SEP aims to improve the existing service network by better meeting demand and providing more frequent and reliable service. Three new alternative routes were designed for Alameda. One of the options presented was the restoration of a version of Line 19 in Alameda, which had been discontinued in 2010 due to budget cuts.

AC Transit held a community workshop in Alameda in October 2015 and a public hearing in November 2015. AC Transit and City staff presented and discussed SEP recommendations at the Interagency Liaison Committee between AC Transit and City of Alameda representatives on October 14, 2015 and January 6, 2016. The Transportation Commission and the City Council approved the Buena Vista Avenue/Line 19 restoration alternative on January 27, 2016 and February 2, 2016, respectively. The AC Transit Board approved this alternative on March 9, 2016.
