Dear Rochelle Wheeler

I am very upset about the restoration and addition of bus stops along Buena Vista Ave. for AC Transit's Line 19. I have lived at 2304 Buena Vista Ave. for 47 years. We were a Truck and Bus route for so many years. The Truck route is now on Clement (which we fought long and hard for) and that is where the bus route needs to be for the following reasons: We have traffic all day long. The traffic sits at the signal at Oak and Buena Vista Ave. which is at the corner of our street. We smell exhaust, hear the running of engines and cannot on many occasions leave our own driveways to go out to the street. We even today have big rigs go on our street, many at night ignoring the curfew or routing. We are now zoned residential. Our houses get so dirty. I know the buses run all day and night. This noise is too much for our neighborhood. We were all sick a lot more when the Trucks and Buses ran down our street. We have just begun to sleep through night.

A C Transit has those Trans bay Express buses which are too large for our street. We are only 2 lanes many times its dangerous to open the drivers door on a parked car unless you wait for the cars to stop at the red light. Can you imagine the buses. We cannot afford to lose any parking on Buena Vista Ave. My block has many renters coming and going. Some places you know about as Apartments but a lot you do not know about where owners rent parts of their houses. We have no spare parking. We also have a church across the street which brings cars all day long. They do not have a parking lot. Our side of Buena Vista is street sweeping (whether it gets done or not) no parking Wednesday a.m. so early; people cannot park over night. I have been watching the 2 parking spaces you want to eliminate going to Webster St. by the Animal hospital. There have been two cars there every time I look. We even cannot park on the street so we have space off the street for 3 vehicles. Our two neighbors at 2300 and 2302 have no driveways. They must park on the street but rarely get a spot close to there house. We also have workers parking on our street and walk to work due to meters on Park St. In addition we have park and ride people who park then walk to Park st. and park all day. Also people parking and going shopping or to eat on Park St. to avoid parking meters. The buses when they did run down our street would regularly hit the hydrant on the corner of Oak St and Buena Vista Ave. We cannot afford in our drought condition the water and cannot afford the city maintenance crews here to replace it. If A C Transit buses go down Buena Vista we have 2 stop signs now that the trucks are off our street. Buses will have to stop here and they will back traffic in both directions. Again will be idling. When they would pull over to get riders would cars be able to get around them as traffic is heavy in both directions. Clement has no stop signs from Oak St. to Grand st. that's why it works so well for the trucks. It is not all residential like our street. The right side is all business. It was wide enough for the train and cars. Back when the city had calm Alameda streets meetings we were told that we were also an emergency route. Fire Trucks/Ambulances and Police. They are going on our street all the time with the sirens going full blast. How will this work when Buses are holding up traffic. How will they get around them safely? Is this a done deal before comments and the meeting on May 25th? I have seen buses on our street for the last couple weeks. Just saw a bus Sunday 5/8/2016 at 11:30 p.m. going to Park St. on Buena Vista Ave. much faster then 25 MPH. I saw a Trans

about 1 week ago and 2 regular buses the 2 weeks before that.

I will be out of the State on May 25th and unable to attend the meeting. PLEASE RE ROUTE THE BUSES TO CLEMENT TO USE THE TRUCK ROUTE. THANK YOU

As noted in the staff report and Exhibit 3, AC Transit prefers farside bus stops. We wish we could that in this case.
