FY 2015-16 Highlights

- General Fund (GF) revenues \$4.3 million better than original estimate
- GF expenditures (excluding those appropriated from available reserves in September 2015) were slightly under the original budget
- Reserves (GF available balance) at 6/30/16 projected 24% of expenditures and transfers out

FY 2015-16 Highlights

- Allocation of accumulated General Fund Available Reserves
 - > \$0.9 million in GF appropriations
 - > \$3.5 million in GF transfers out
 - > \$9.5 million in GF committed reserves
- \$2.2 million loan repayment from AMP
- Rent Stabilization (new fund)
 - ➤ New program established by the City Council
 - > \$300,000 General Fund seed money to start up the program

Mid-Cycle (FY 2016-17) General Fund Update

- General Fund (GF) revenues \$1.9 million over original estimate
- GF expenditures \$1.1 million over original budget
- GF Net Deficit reduced from \$1.2 million to \$0.8 million
- GF available reserve at 6/30/17 is projected to remain at 24% of expenditures and transfers out

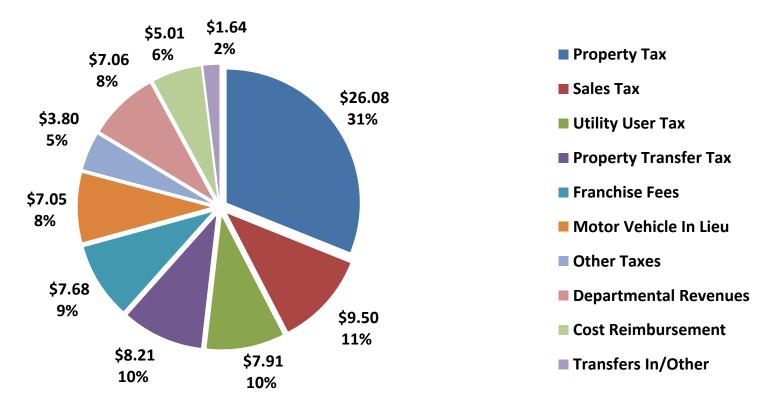

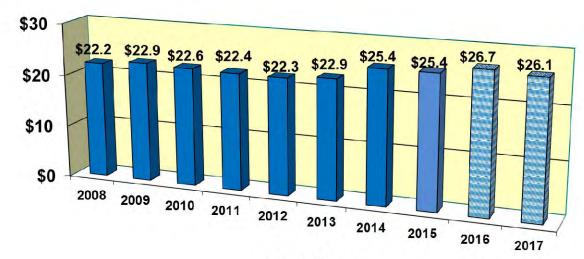
FY 2016-17 General Fund Revenue

Property Tax Revenue

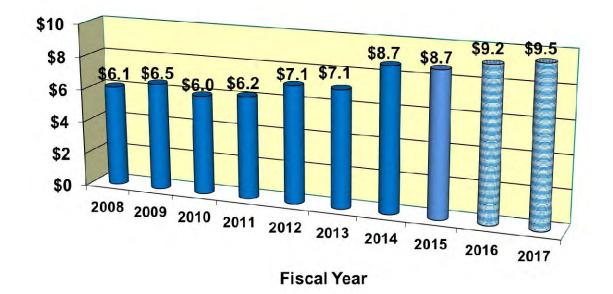
- Property Tax (excluding "waterfall funds" from former RDA) is expected to increase \$0.7 million from prior year
- *"Waterfall funds" are estimated at \$0.9 million in FY 2016-17
- ❖ The City receives about 25% of the 1% ad valorem tax



Fiscal Year

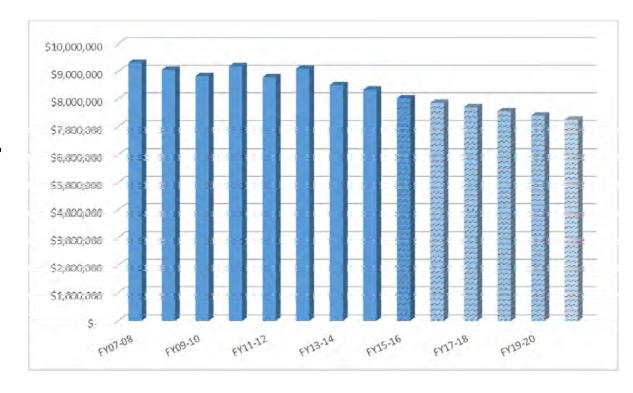
Sales Tax Revenue

- Sales Tax is expected to increase 3% or \$0.3 million from prior year
- ❖ The City receives 95% of the 1% Bradley Burns tax. 5% goes to the Alameda County.



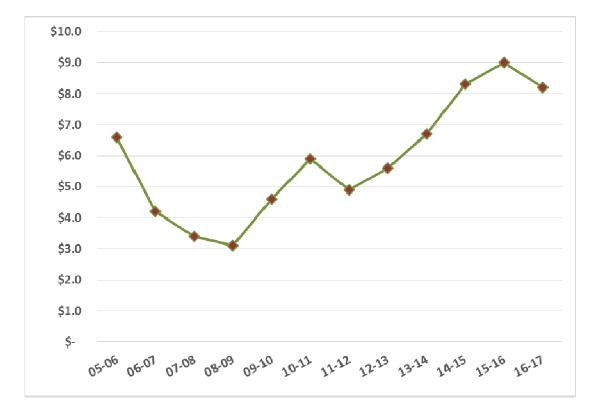
Utility Users' Tax Revenue

- UUT is expected to decrease \$0.1 million compared to prior year
- Current projection does not include potential UUT increase.
- ❖ Modernization of the Ordinance requires voter approval and is expected to result in net benefit of \$1.5 million (back to FY 2007-08 level)



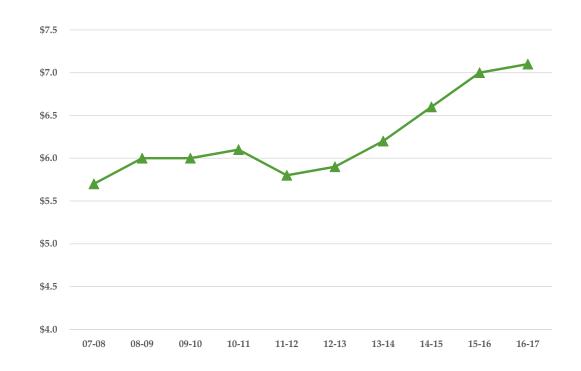
Property Transfer Tax Revenue

- Property Transfer Tax is expected to decrease \$0.8 million from prior year
- ❖Includes \$0.2 million in one-time receipts for large commercial sales (Alameda Point property)



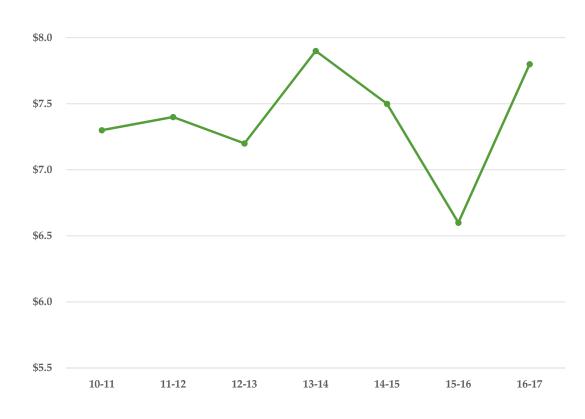
Motor Vehicle In-Lieu Revenue

MVIL is collected through property tax and is expected to increase \$0.1 million from prior year



Franchise Fee Revenue

- *Franchise fee is expected to increase \$1.1 million from prior year
- Collected on gas, cableTV and garbage
- Includes AMP and Sewer Funds PILOT and AMP Transfer per Charter
- Current projection assumes AMP Transfer to continue



Departmental Revenues

- *Fire Department GEMT program reimbursement of \$0.5 million (one-time)
- ❖Public Works estimates \$0.1 million decrease due to drop in fuel cost.

Expenditure Assumptions

- No COLA for contractual services
- Labor (MOUs)
 - Salary increases 3% 4%
 - Health care costs increases 1.8% for Safety and 3.5% for Misc.
 - PERS Rates 33.751% for Safety and 19.265% for Misc.

Expenditure Assumptions

- Labor (other)
 - Vacancy savings estimated at \$0.5 million
 - Fire Department OT increase of \$0.3 million to \$0.8 million due to unfilled SAFER grant positions
 - City Council benefit package (described later in the presentation)
- Workforce Changes (described later in the presentation)

Base Reuse

- \$750,000 Increase in leasing revenues
- \$1,017,000 Increase contractual services to pay for the port services and property managers



Fleet Industrial Supply Center (FISC)

 \$433,000 – Increase in contractual services to cover cost of Economic Development Strategic Plan and business assistance.





Rent Stabilization

- Establish appropriations for a new fund
- Provides funding for City Attorney,
 Finance, Community Development and Alameda Housing Authority (AHA)
- \$493,000 General Fund support to cover the cost of AHA contract through December 2016, until program fee is approved by Council

Development Impact Fees (DIF)

- Anticipated revenue of \$3.5
 million from Del Monte, 2100
 Clement and Alameda Landing
 Projects
- DIF fees are collected for Streets & Roads, Parks, Public Facilities and Public Safety









Capital Improvement Projects

- Krusi Park Rec Center increase budget by \$0.6 million funded by Measure WW and Dwelling Unit tax
- Estuary Park increase budget by \$0.2 million funded by Development Impact Fees

Capital Improvement Projects

- Jean Sweeney Park increase budget by \$2.0 million funded by Land & Water Conservation Fund grant
- Library increase appropriations by \$0.5 million funded by remaining funds from the Library bond and interest earned on those funds

- Delete on Construction Inspector
- Add one Public Works Project Manager I
- Delete one Assistant Engineer
- Add on Public Works Project Manager III
- Delete Public Works Project Manager II
- Add one Program Specialist II
- Delete on Program Specialist I

- Total number of allocated Position will be 521 including the 96 Alameda Municipal Power employees.
- Total Cost of workforce changes is estimated to be \$396,067
 - General Fund \$138,000
 - Rent Stabilization \$231,000
 - Other Funds \$27,067

Mayor and City Council Total Compensation

Recommendations:

- Link Health Benefit contribution and Car Allowance to Executive Management.
- Cap City Health Insurance contribution similar to City Employees
 - From \$2,642/mo. To \$2,255/mo.
- Increase the car allowance
 - From \$104.22/mo To \$250/mo.
- New Technology Allowance \$100/mo.
- Total additional compensation of \$2,952 annually or \$246 monthly per member.
- Effective the first pay-period following January 1, 2017.
