that:

Section 1. The Alameda Municipal Code is hereby amended by codifying Ordinance No. 1676, N.S., adopted September 6, 1972, attached hereto, as Section 2-15 to Article II (Boards and Commissions) creating the City of Alameda Disaster Council.

Section 2. This ordinance shall be in full force and effect from and after the expiration of thirty (30) days from the date of its final passage.

New Series CREATING THE CITY OF ALA-MEDA DISASTER COUNCIL, PRO-VIDING FOR MEMBERSHIP, DL RECTOR AND OTHER OFFICES THEREOF, PRESCRIBING DUTIES, FUNCTIONS AND RE-SPONSIBILITIES OF SAME, AND REPEALING ORDINANCE NOS. 1029, 1142 AND 1575, NEW SERIES. **New Series**

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALAMEDA: SECTION 1. PURPOSES.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALAMEDA: SECTION 1. PURPOSES. The declared purposes of this ordinance are to provide for the preparation and carrying out of plans for the protection of persons and property within this city in the event of an emergency: the direction of the emergency organization: and the coordination of the emergency functions of this city with all other public age n cies. corporations, organizations, and affected private persons. SECTION 2. DEFINITION. As used in this ordinance. "emergency" shall mean the actual or threatened existence of conditions of disaster or of extreme peril to the safety of persons and property within this city caused by such con-ditions, including conditions resulting from war or im-minent threat of war, but other than conditions resulting from a labor controversy, which conditions are or are likely to be beyond the control of the services, personnel, equip-ment, and facilities of this city, requiring the combined forces of other political subdivisions to combat. SECTION 3. DISASTER COUNCILMEMBERSHIP. The City of Alameda Disaster Council is hereby created and shall consist of the following: A. The Mayor, who shall be Chairman.

B. The City Manager who shall be the Director of Emergency Services and Vice-Chairman. C. The Assistant Director of Emergency Services. D. Such chiefs of emergency services as are provided for in a current emergency plan of this city, adopted pursuant to this ordinance. E. Such representatives of civic. business, labor, veterans, professional, or other organizations having an official emergency responsibility, as may be appointed by the Director with the advice and consent of the City Council. SECTION 4. DISASTER COUNCIL POWERS AND DUTIES. It shall be the duty of the City of Alameda Disaster Council, and it is hereby empowered, to develop and recommend for adoption by the City Council, emergency and mutual aid plans and agreements and such or and recommend for adoption by the City Council, emergency and mutual aid plans and agreements and such or-dinances and resolutions and rules and resolutions as are necessary to implement such plans and agreements. The Disaster Council shall meet upon call of the Chairman or. in his absence from the city or inability to call such meeting, upon call of the Vice-Chairman. SECTION 5. DIRECTOR AND ASSISTANT DIRECTOR OF EMERGENCY SERVICES. A. There is hereby created the office of Director of Emergency Services. B. There is hereby created the office of Assistant Director of Emergency Services, who shall be appointed by the Director.

SECTION 6, POWERS AND DUTIES OF THE DIRECTOR AND ASSISTANT DIRECTOR OF EMERGENCY SERVICES.
A. The Director is hereby empowered to:
(1) Request the City Council to proclaim the existence of a "local emergency" if the City Council is in session. or to issue such proclamation if the City Council is not in session. When ever a local emergency is proclaimed by the Director, the City Council shall take action to

SECTION 8. EMERGENCY PLAN. The City of Alameda Disaster Council shall be responsible for the develop-ment of the City of Alameda Emergency Plan. which plan shall provide for the effective mobilization of all of the resources of this city, both public and private, to meet any condition constituting a local e m er g e n c y. state of emergency; and shall provide for the organization. powers and duties. services, and staff of the emergency organization. Such plan shall take effect upon adoption by resolution of the City Council. S E C T I O N. 9. E X. P E N D I T UR E S. Any ex-penditures made in connection with emergency activities. including mutual aid activities. including mutual aid activities. shall be deemed conclusively to be for the direct protection and benefit of the inhabitants and property of the City of Alameda. SECTION 10. PUNISHMENT OF VIOLATIONS. It shall be a misdemeanor, punishable by a fine of not to exceed five hundred dollars (\$500), or by imprisonment for not to exceed six months, or both, for any person, during an emergency. A. Willfully obstruct, hinder, or delay any member of the emergency organization in

- Six months of an emergency.
 A. Willfully obstruct. hinder. or delay any member of the emergency organization in the enforcement of any lawful rule or regulation issued pursuant to this ordinance. or in the per-formance of any duty im-posed upon him by virtue of this ordinance.
 B. Do any act forbidden by a n y lawful rule or regulation issued pursuant to this ordinance. if such act is of such a nature as to give or be likely to give assistance to the enemy or to imperil the lives or property of inhabitants of this city, or to prevent. hinder. or delay the defense or protection thereof.
 C. Wear, carry, or display, with o ut authority, any means of identification specified by the emergency agency of the State.

SECTION 11. REPEAL OF CON-FLICTING ORDINANCES. Ordinance Nos. 1029, 1142 and 1575. New Series, be and the same hereby are, and each

is, repealed, SECTION 12. EFFECTIVE DATE. This ordinance shall become effective thirty (30) days from and after its days f

SECTION 13. SEVERABILITY. If any provision of this ordinance or the any provision of this ordinance or the application thereof to any person or circumstance is held invalid, such in-validity shall not affect other provi-sions or applications, and to this end the provisions of this ordinance are de-clared to be severable.
