THIRD AMENDMENT TO AGREEMENT

This Third Amendment of the Agreement, entered into this 1st day of July, 2016, by and between the CITY OF ALAMEDA, a municipal corporation (hereinafter "City") and RMC WATER AND ENVIRONMENT, a California corporation whose address is 2175 NORTH CALIFORNIA BOULEVARD, SUITE 315, WALNUT CREEK, CALIFORNIA 94596, (hereinafter "Consultant"), is made with reference to the following:

RECITALS:

- A. On September 23, 2013, an agreement was entered into by and between City and Consultant (hereinafter "Agreement") in the amount of 29,430.
- B. On July 1, 2014, a first amendment to agreement was entered into by and between City and Consultant (hereinafter "First Amendment to Agreement") in the amount of \$43,580.
- C. On July 1, 2015, a second amendment to agreement was entered into by and between City and Consultant (hereinafter "Second Amendment to Agreement") to extend the term.
- D. City and Consultant desire to modify the Agreement to extend the term on the conditions set forth herein.

NOW, THEREFORE, it is mutually agreed by and between and undersigned parties as follows:

- 1. Page 1, Item No. 1, TERM, Paragraph 1 of the Agreement is modified to add the following:
- "The term of this Third Amendment to Agreement shall commence on the 1st day of July, 2016, and shall terminate on the 30th day of June, 2017, unless terminated earlier as set forth herein."
- 2. Except as expressly modified herein, all other terms and covenants set forth in the Agreement shall remain the same and shall be in full force and effect.

"Contract or agreement requiring insurance" means that part of any contract or agreement under which you are required to include the person or organization shown in the Schedule as an additional insured on this Coverage Part, provided that the "bodlly injury" and "property damage" occurs, and the "personal injury" is caused by an offense committed:

- b. While that part of the contract or agreement is in effect; and
- c. Before the end of the policy period.
