Jennifer and Rochelle,

I see that you have created a priority project list for the CIP call for projects. If I am reading it correctly, the estuary crossing bridge feasibility study is NOT on the list.

I understand that you feel that the coast guard issue should be addressed before the city attempts an engineering feasibility study.

However, we feel strongly that the bridge engineering feasibility study needs to be put on the CIP list immediately, so that it even has hopes of getting funding by 2018. If it doesn't, it could be many more years of waiting for the funding with an already long time line.

The TC will be viewing the list on 9/28 and we'd like to see presented to the TC the expected ridership for a **water shuttle, line 31 replacement for the Estuary Crossing Shuttle (ECS) and the proposed modifications to the second walkway of the Posey Tube which the Broadway Jackson project proposes.**

In order for these project to be evaluated and approved for further study by the TC, we respectfully ask that the TC be presented with the potential ridership numbers and benefits to traffic congestion, environment, etc that the proposed projects might have.

Dear Transportation Commissioners:

As you know from our communication to each of you last week, Bike Walk Alameda has been working closely with Alameda City staff on how best to jump start efforts to make progress on what the 2009 Estuary Crossing Study designated as the **preferred long-term solution** for the **number one priority** in our Bike/Ped Plan: a bicycle and pedestrian bridge. After seven years of no progress, we believe that it is past time to take concrete steps here. While we have not reached agreement on Alameda's countywide CIP project list, we do feel there is growing consensus that now is the time to act and that we should work collaboratively to achieve our shared goals.

We believe that seeking funding for Caltrans' proposed study from ACTC in the current cycle is an important opportunity that should not be passed up. If the City of Alameda is not prepared to nominate and take the lead on this project, we believe there are some concrete steps you can take tonight to show genuine commitment to meeting the top policy goal outlined in the Bike/Ped Plan.

1. Direct City staff to formally request Caltrans submit an application and act as the lead as part of this funding cycle. Due to extreme time sensitivity, this needs to be drafted and sent in a matter of days, not weeks.
2. Direct City staff to work in consultation with Bike Walk Alameda to develop steps for Transportation Commission and City Council approval that will guide efforts to make measurable progress on a bike/ped bridge for West Alameda.
3. Direct City staff to be prepared to find and allocate resources of staff time and dollars to advance the preferred solution of a bridge while proactively engaging stakeholders such as Caltrans, City of Oakland, County of Alameda, and the Coast Guard in efforts to **#BridgeTheGap**.

Dear Commissioners,

Please only approve a priority project list that includes the feasibility study for a bicycle and pedestrian moveable bridge between west Alameda and Oakland. A bicycle and pedestrian bridge would fix the network gap here by offering users 24/7/365 access that is easy-to-use, safe and enjoyable. In addition, a bridge will get more people out of the Tubes than any other proposed alternative, easing congestion and benefiting even those that don't use it. A bridge was the recommended long-term solution in the 2009 Estuary Crossing Feasibility Study, but it's been seven years since any progress has been made on it. Let's not delay any longer. I urge you to take this opportunity and include the study in the project list as the next important step in addressing this high-priority issue.
