APPROVING ONE WORKFORCE CHANGE AT ALAMEDA MUNICIPAL POWER: ADD ONE NEW POSITION, UTILITY DISTRIBUTION AUTOMATION ANALYST; AND AMEND THE SALARY SCHEDULE OF ELECTRIC UTILITY PROFESSIONALS OF ALAMEDA (EUPA) TO ADD THE CLASSIFICATION TITLE OF UTILITY DISTRIBUTION AUTOMATION ANALYST, EFFECTIVE JUNE 25, 2017

WHEREAS, in order to provide a workforce that is appropriately allocated, classified and compensated at Alameda Municipal Power workforce change are needed; and

WHEREAS, to meet service demands related to system upgrades and projects the Public Utilities Board recommended at its regular meeting on March 21, 2017 that the City Council add one Utility Distribution Automation Analyst; and amend the salary schedule of the Electric Utility Professionals of Alameda (EUPA) to add the classification title of Utility Distribution Automation Analyst.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Alameda that the following workforce change is approved and that the City's authorized positions are so modified:

Alameda Municipal Power

- a. Add one Utility Distribution Automation Analyst position; and

NOW, BE IT FURTHER RESOLVED by the Council of the City of Alameda that the salary schedule of the Electric Utility Professionals of Alameda (EUPA) is hereby amended effective June 25, 2017 to establish the salary rates, salary ranges, salary steps and benefits for the classification of Utility Distribution Automation Analyst, designating these as applicable to this classification in the service of the City of Alameda.
