### **Re: Support for Jill Keimach – Setting the Record Straight**

Dear Mayor Spencer and Members of the Alameda City Council:

I've served on the Moraga Town Council since 2006, and as Mayor in 2009 and 2013. I was thus personally involved in interviewing, and ultimately selecting, Jill Keimach in 2010 to serve as Town Manager here in Moraga. As a sitting Councilmember, I worked very closely with Jill over the ensuing five years before her departure to Alameda. I can attest from firsthand experience that Jill Keimach was an outstanding Town Manager. She was appreciated by the Town Council and widely admired by the community for her leadership, personal qualities and acumen in dealing with all manner of governance issues here in Moraga. We were very sorry to see her leave. We still miss her here in Moraga.

It's now come to my attention that someone with a political axe to grind attended the October 17, 2017 meeting of the Alameda City Council to speak critically at Public Comment regarding Jill's tenure as the Moraga Town Manager. Referring to having "represented" the teachers of Moraga, this individual claimed it was "no surprise" that Jill "failed" as Town Manager, and was about to be "fired" when she left for Alameda.

Such statements are both laughable and totally false – plain and simple. You should give no credence whatsoever to them.

The Superintendent of the Moraga School District, Bruce Burns, will also be present at your November 7, 2017 City Council meeting. Superintendent Burns is in a unique position to address the lack of veracity on the part of the previous speaker regarding Jill Keimach and her relationship with Moraga teachers in particular. Respectfully, I would encourage you to let him speak at Public Comment this evening.

What I can definitively add here is this. Jill's arrival in Moraga coincided with a noticeable improvement in relations between the Town and the Moraga School District. As a sitting Councilmember, I never heard a single criticism about Jill Keimach from any Moraga teachers, or their union representatives for that matter.

The reality is that everyone here in Moraga loved Jill Keimach for who she was, and continues to be. Jill displayed excellent skills and integrity as a consensus builder as Town Manager. She got along with everyone. Rather than erect walls, I watched as she built bridges between the Town of Moraga and stakeholders throughout the Moraga community.

Thank you for your careful consideration of these comments, and for the opportunity to bring this information to the Alameda City Council's attention this evening.

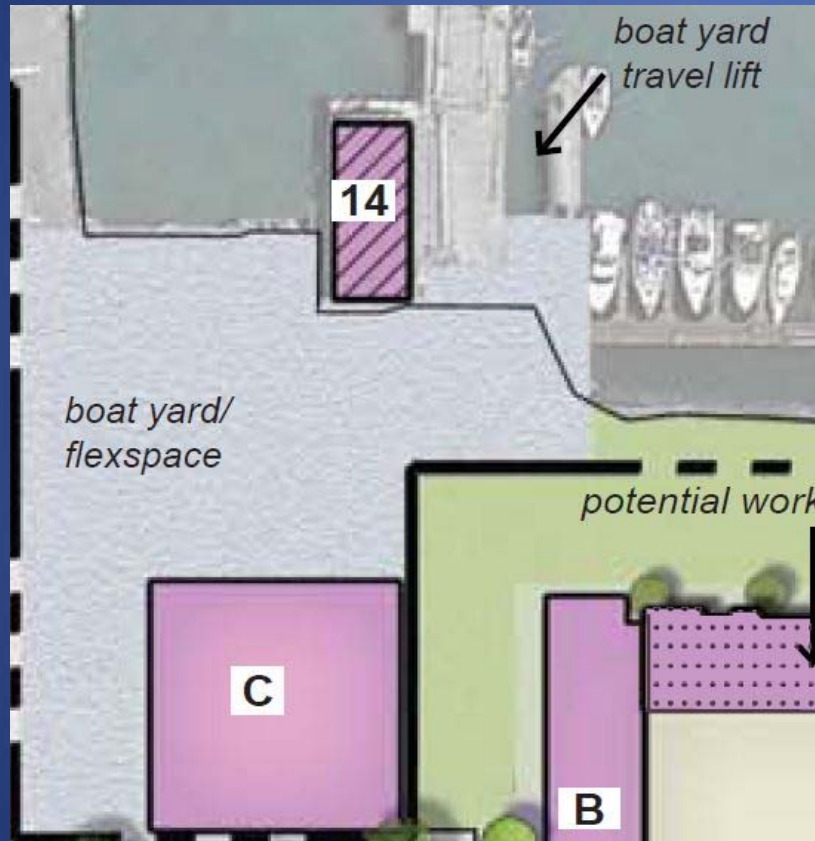

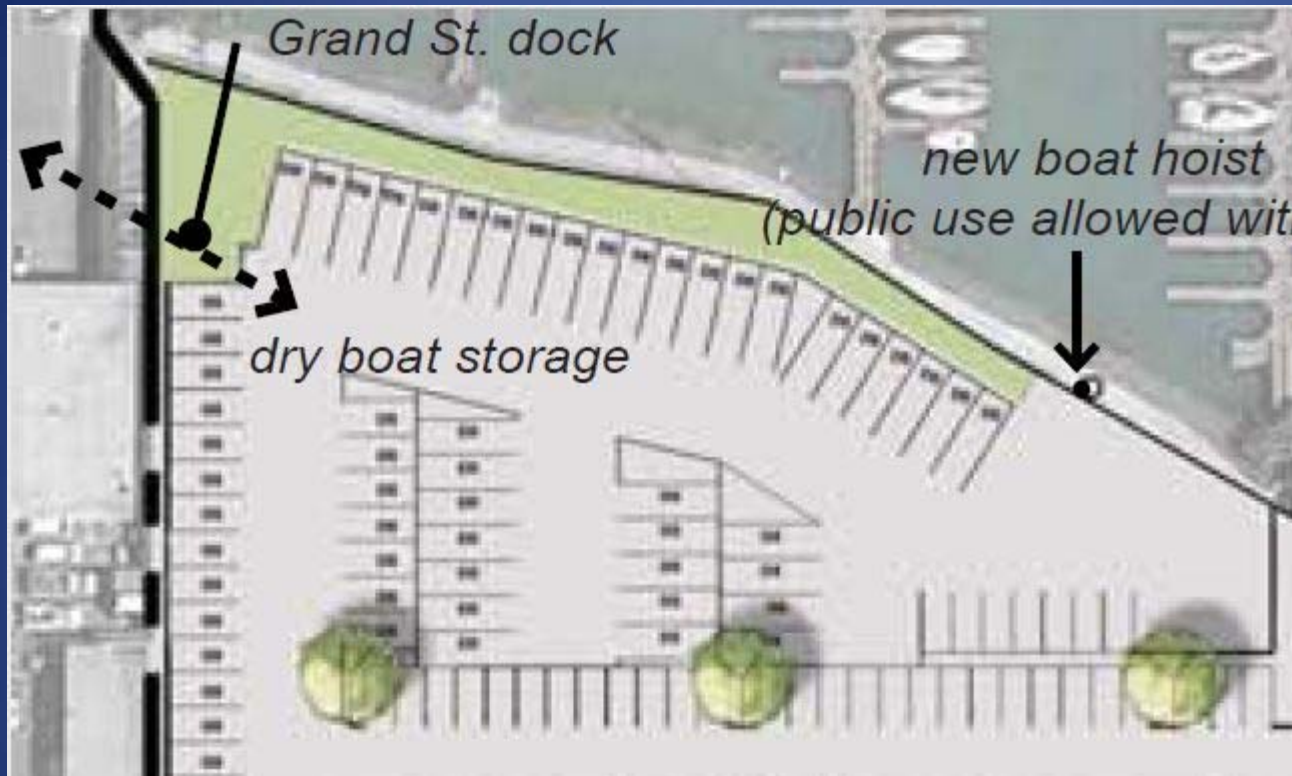

## Proposed Dry Storage:

Beginning January 1, 2018, Svendsen's renowned team of experienced boatwrights, riggers and metal fabricators will join forces with Bay Marine Boatworks in Richmond, Calif., to become the premier boat repair facility in Northern California.

The soon-to-be combined facility in Richmond will include an expansion of Bay Marine's existing boatyard with use of recently acquired land, as well as state-of-the-art environmental improvements. The site will also include a new marine store, which is presently in the planning stage. Svendsen's/Bay Marine customers in Richmond will have access to the full cache of services, including bottom and topside painting, rigging fabrication and installation, fiberglass and wood repair, metal fabrication and repair, engine repair and repower, custom refits and a 100-ton Travelift capacity.

"The quality and depth of experience we are creating in our Richmond yard will be unparalleled on the West Coast. Our larger Travelift capacity should also be a bonus for Svendsen's customers with larger boats," said Bill Elliott, President and CEO, Svendsen's Boat Works. "The re-designed Svendsen's/Bay Marine facility in Richmond will become a true destination yard with outstanding customer service. We welcome and encourage all current Svendsen's customers to visit our new location in 2018."

In January 2017, Bay Maritime, which owns Bay Marine Boatworks and Bay Ship & Yacht in Alameda, Calif., acquired all of the divisions of Svendsen's, including Svendsen's Marine Distributing, Svendsen's Rigging Shop and Svendsen's Metal Works. Svendsen's products divisions, including the Wholesale Distribution and Chandlery, will continue to operate in the current location in the Alameda Marina.

Svendsen's existing boatyard in Alameda will close its operations on November 3, 2017, to facilitate the company's relocation to Richmond, and the eventual redevelopment of the Alameda Marina. While most of the Svendsen's employees will transition to the new Svendsen's/Bay Marine facility, some will transfer to Bay Ship & Yacht's full-service shipyard in Alameda.

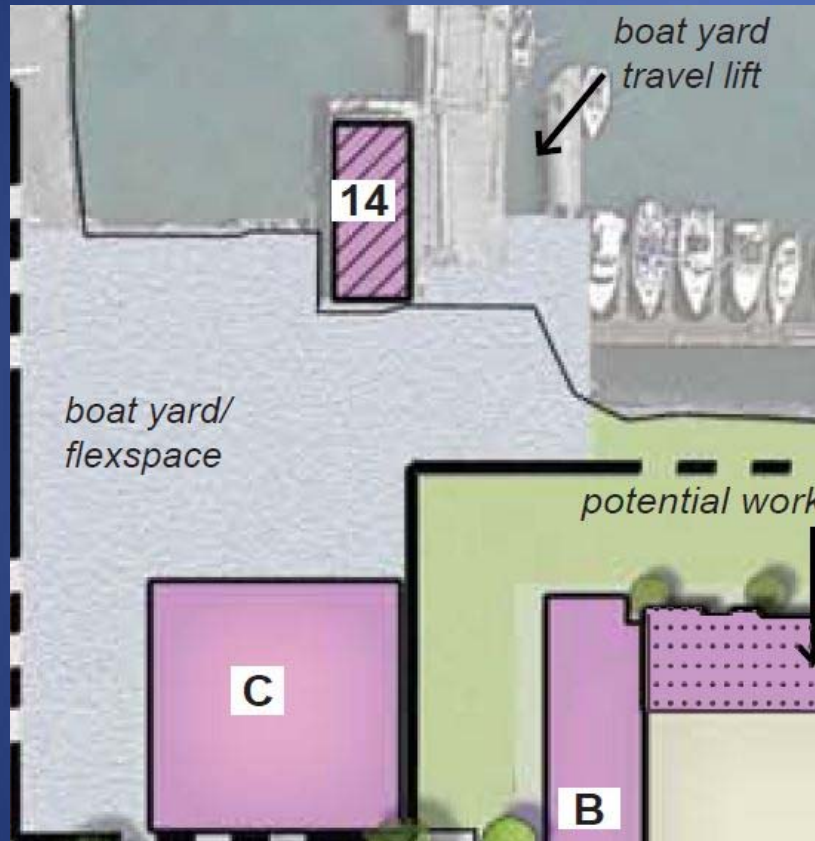

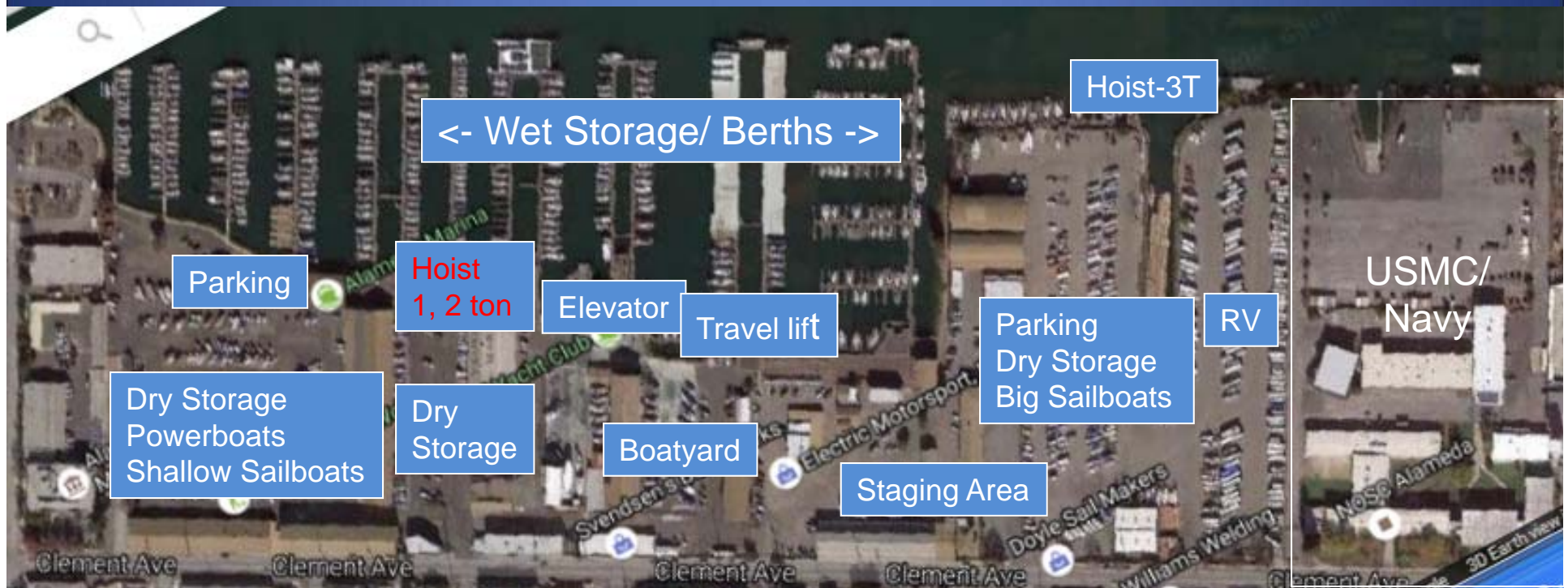


Exhibit 3.3 - Conceptual Birdseye perspective from southeast of Master Plan at full development

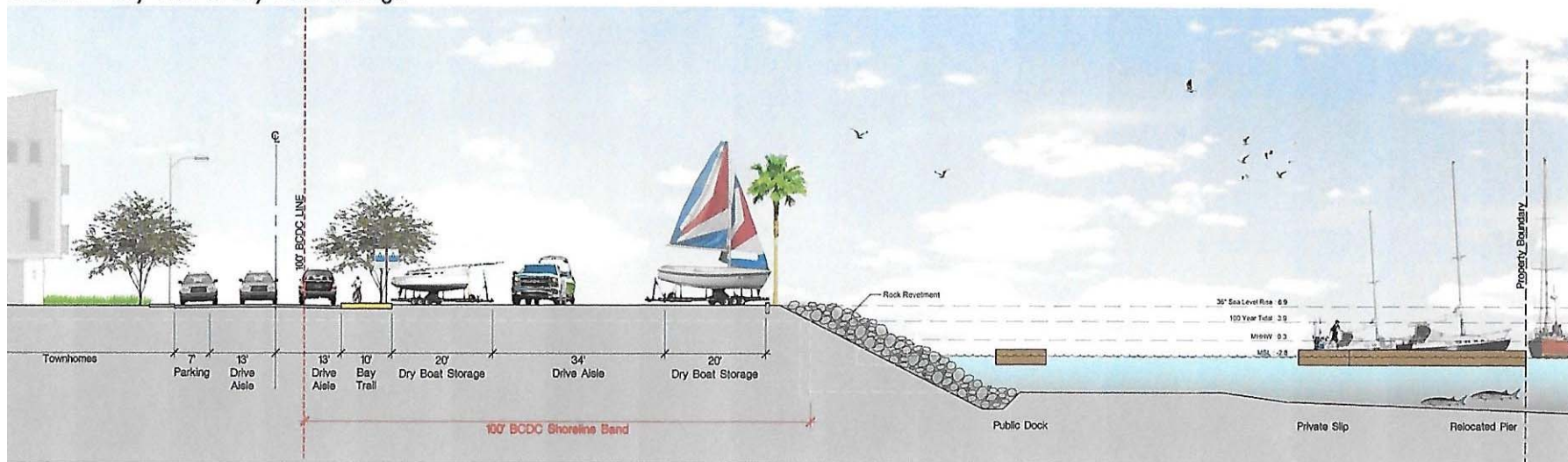

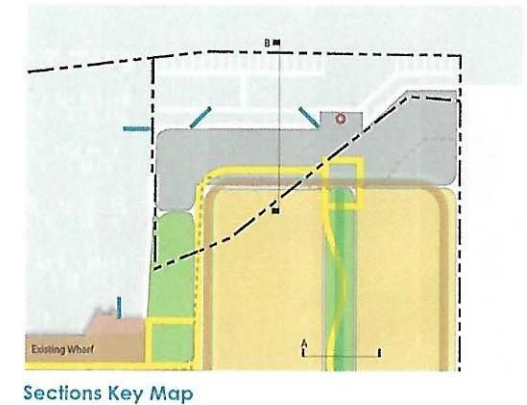
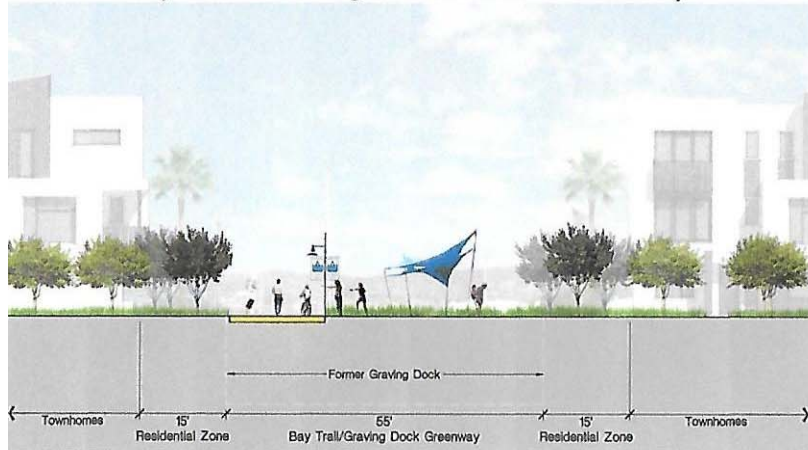




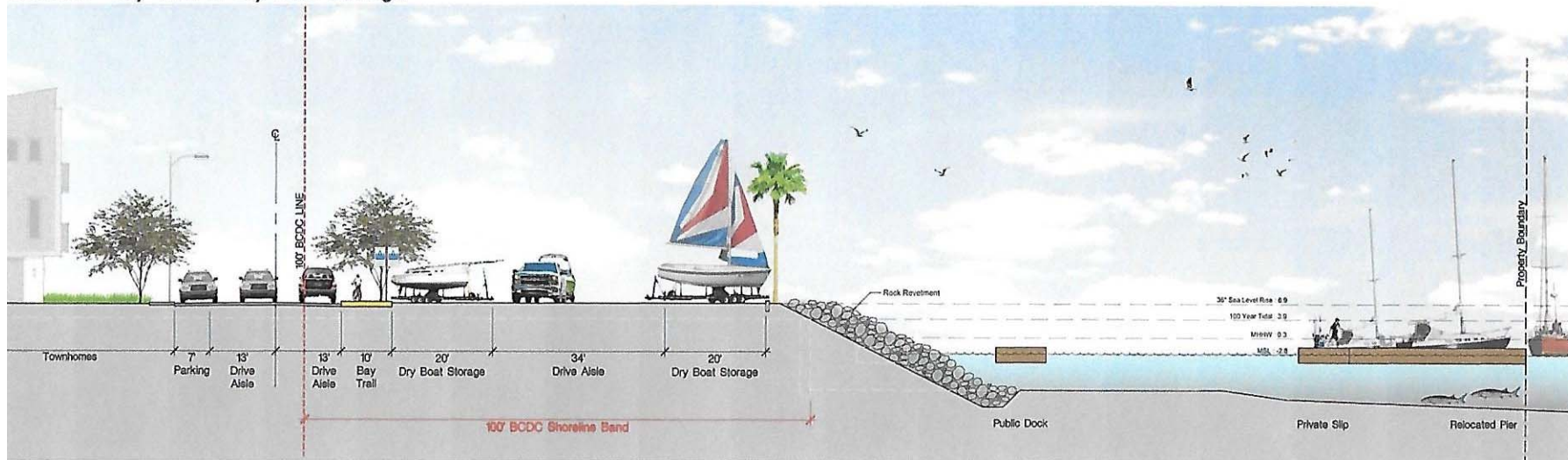
Exhibit 3.3 - Conceptual Birdseye perspective from southeast of Master Plan at full development

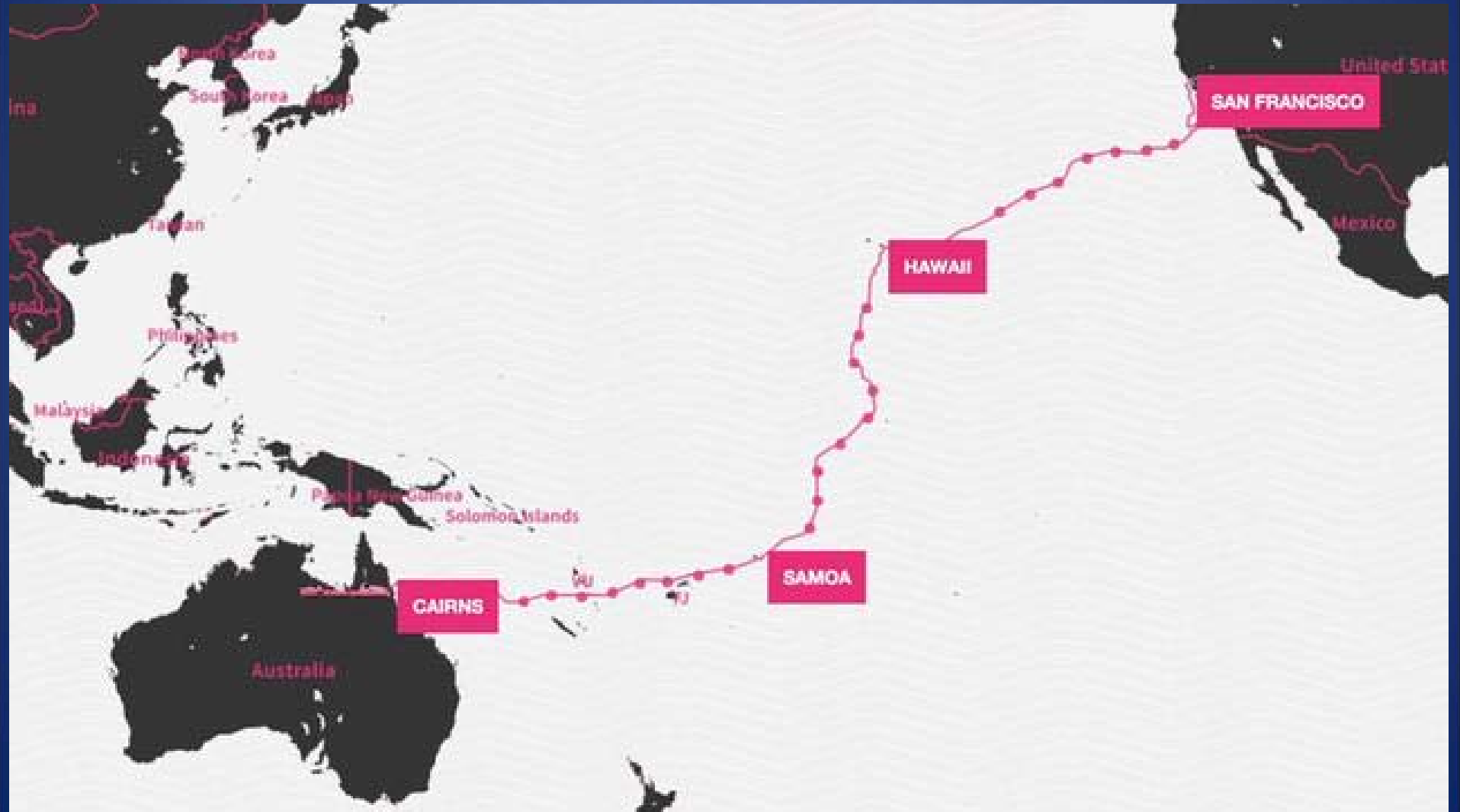

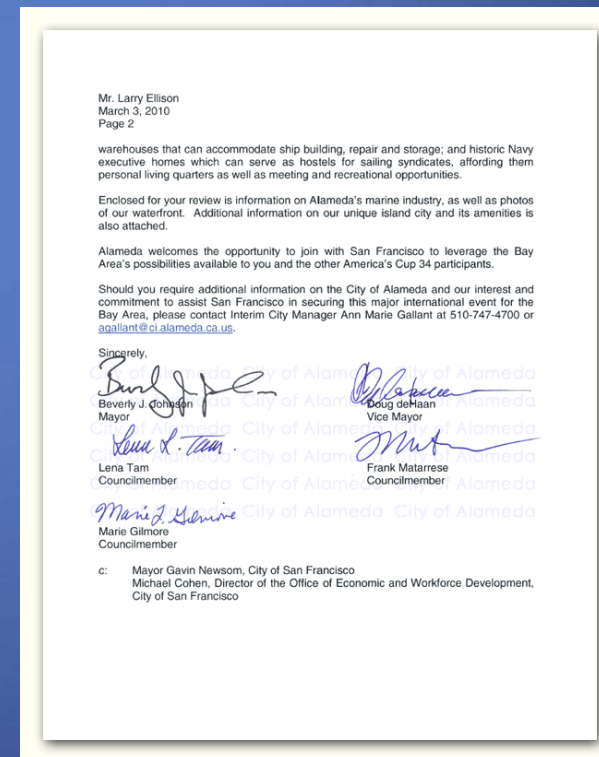
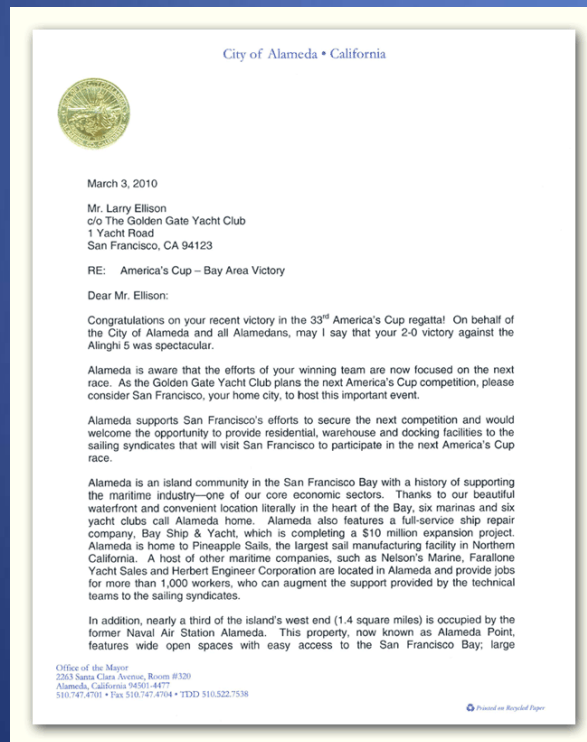
