Currently working on a 700 acre site called Mallard Farms Conservation Bank in Solano County that will develop and protect sensitive tidal marsh habitat for various protected fish species. This includes all phases of planning and permitting, working directly with 14 landowners and 5 land parcels, engineers, biologists and various state and federal personnel to gain permit approval; specifically:

- Consolidated 51% of mineral rights to surface rights owner and renegotiated access to mineral right by limiting access to designated drill sites.
- Negotiated new pipeline Right-of-Way agreements with several pipeline owners including Chevron, Calpine and PG&E to allow for the conservation and protection of waters and habitat over the pipelines and limiting access to the pipelines for repair and maintenance to designated drill sites.
- Worked with Biological and Legal Team to develop a Bank Enabling Instrument that was submitted to state and federal agencies seeking approval for a conservation easement that will designate the property as a protected conservation bank.
- Moved the project through the CEQA process, successfully overcame multiple comment letters from various county, state and federal agencies. Currently negotiating an acceptable settlement to our final comment letter to satisfy all CEQA requirements and close CEQA.
