Dear Members of the Council:

I wanted to speak to you about the proposal the Alameda City Council will be considering to declare the West Bank village of Wadi Foquin a sister city. This proposal is being put forward by Reverend Michael Yoshii of the Buena Vista United Methodist Church.

I understand the intent of the Sister Cities organization to promote understanding of other cultures, however the recent activities appear to be part of a concerted religious and political agenda to increase sister city relationships between Palestinian cities and the United States, especially by the Methodist Church and Sister Cities International board member, John Dabeet, a Palestinian expat.

Currently there are only a handful of US cities, and only one here in California (Sacramento – but also has a sister city in Israel). There have been considerable conflict around these decisions – in Boulder, CO, it caused such dissent that they had to have mediators come in to help navigate the tears in the community. The town of Wadi Foquin is currently part of the very controversial settlement zone. Articles about them speak of their "fight for existence" in occupied territories. Regardless of ANYONE'S geopolitical views, this is not a peaceful or stable government or area. Individuals have every right to lobby, protest, or support whichever side they wish. My problem is putting the City of Alameda and its residents in the middle of it – giving the impression of taking sides. Unfortunately, due to the current climate of our country, it is simple to see progressions of this relationship to anti-Israel and anti-Semitic behaviors.

There are already problems with anti-Semitism in Alameda, as seen with the vandalism of Temple Israel and the repeated anti-Semitic incidents in our schools. My daughter's friend, Natasha, spoke to the city council in September about her struggles with anti-Semitism in our school district. She has been victim of multiple anti-Semitic threats, and subjected to other anti-Semitic incidents. Last Friday, my daughter and Natasha discovered more anti-Semitic graffiti in one of their classrooms.

According to a recent letter from the principal at Alameda High, there have been 14 reported cases of symbolic violence or acts of intolerance just since September 15, including numerous anti-Semitic incidents! I am proud of the work AHS is doing to handle these incidents and the subject overall. However, we need to be cognizant of repercussions for a sister city relationship that may accelerate these types of incidents.

Based on the research I've done, it seems that this resolution is largely being pushed by Reverend Yoshi and the Buena Vista United Methodist Church. If you were to check online, you will find that most, if not all Facebook pages for Palestinian Sister City projects (a step in the approval process) are formed in conjunction with the Methodist church. They also, interestingly, have only about 200 followers. I am concerned about the high involvement of a church into government decisions.

This is an extremely controversial issue and the city council should not be a stance. We don't need another excuse for anti-Semitism in our city. However, if the city were to move forward with this proposal – since I have heard that there are members in favor of this proposal -- I would hope that they would also be as favorable with a Sister City proposal with Israel and would support efforts for a multilateral approach. My family and I live in Alameda for the last 15 years.

I just learned about the proposal to establish a sister city with the city of Wadi Foquin. While I general, I am not opposing forming sister relationship with a Palestinian city in the West bank, I believe that in this case it will be viewed as a political statement by the city of Alameda and will create an inflammatory environment for several reasons:

This proposal is being submitted by Rev. Michael Yoshii who chaired the United Methodists for Kairos Response, a group active in the Boycott, Divest and Sanction (BDS) movement, which the Anti-Defamation League recognizes as anti-Semitic.

In addition, in the past months, we witnessed increased anti-Semitic activity in Alameda, including several incidents in AHS and Temple Israel.

Signing a sister relationship under these conditions will unintendedly send a negative message to Jews living in Alameda and I strongly propose to consider other options.

As an example, Alameda could establish and declare sister relationship with a Palestinian city and an Israeli city <u>at the same time</u>, <u>under the same resolution</u>. This will send a message of peace for everyone living in Alameda.

For whatever it is worth, would someone please forward this email ASAP to the City Councillors not mentioned below. I will send it to the Mayor and the four listed members. Thank you.

Dear City Council,

Greetings from the Sultanate of Oman which I am visiting after a conference in the United Arab Emirates. Although I am Jewish, you can tell that I have no problem working or talking with Arabs per se. I have done so for over 40 years. Many Arabs, however, do have a problem with Jews and Israel as one can tell every day by reading the local press articles in English. Most of what they write is based in fact but are usually half truths. One such article this past week spoke about the corruption of the Israeli government. While that was true, the same article conveniently neglected to mention that Israel is a society of laws where corrupt politicians have been jailed and that before criticizing others, Arab societies should ask what would happen if they raised the same charges against their own leaders.

My very open-minded and world-travelled tour driver today told me that when he was in school 20 years ago, the Omani curriculum taught him that Jews are money-grubbing leaches who shoot Arabs and are totally untrustworthy. And this in one of the world's more liberal Arab countries. He is unaware of what current Omani students are being taught. However, mountains of documentary evidence shows that the Palestinian public school curriculum follows similar trends. For example, a math problem would ask, "If our martyrs ambushed ten Israeli soldiers and killed seven, how many Zionist pigs would remain alive for future confrontations?".

As do many liberal Jews, I totally support an independent Palestinian state and abhor Israel's settlement policies and land grabs. I totally and personally empathize with Palestinian anger at the daily frustrations and humiliations many endure. However, after 50 years of occupation, two intifadas, and Israeli offers of a political resolution in 2000 and 2003 and beyond, the status quo remains. The issue ultimately becomes whether more of the same actions will generate a transformation or whether other, totally different alternatives can achieve the independence Palestinians seek.

Ultimately, the Palestinians focus on decades of injustices and Israelis focus on decades of insecurities. Both viewpoints are valid but a resolution can only start when both sides recognize the validity of the other's realities ... and change their behaviors.

I greatly applaud Buena Vista UMC's and Wadi Foquin's mutual efforts to improve that town's economic well-being. Those are critical steps to create prosperity and break the cycle. BUT no where does the resolution show Wadi Foquin's political actions.

To bestow the gift of a sister-city relationship, the Alameda Council should first ask what visionary, moral leadership Wadi Foquin's city council has demonstrated. Is Wadi Foquin taking a transformational path as Gandhi would have done? Or are they simply perpetuating Arab half-truths, lies and lsrael-bashing? Are the town's schools and newspapers a mouthpiece for continued negativity? Or do they foster mutual understanding? What moral courage and leadership has its council shown to demonstrate a positive way out of the impasse? Or is WF's council perpetuating the Palestinian party line? **If you do not know, it is best to table your decision until you can find out.**

In general, Muslims and Arabs want the rest of the world to understand them but they do not seek to understand the world. And in Arab societies, questioning can be dangerous. With Israel-Palestine, you are not dealing with a simple, uncharged relationship as with Korea and the Philippines. <u>Nice ceremonies</u> and people-to-people exchanges in this case show legitimacy, not <u>dismay</u>. If Alameda City Council is not going to postpone a decision or refuses to take additional, costly actions to help Wadi Foquin break its ingrained mindset, I suggest that you deny this relationship.

Good afternoon, Genevieve,

It was good talking with you this afternoon. As I mentioned, the folks I talked to at the city have told me that they have received no letters in opposition to the Palestinian Village Wadi Foquin sister city proposal that is going to be considered at the Council meeting this coming Tuesday. There are a number of letters supporting the proposal that are included in the council packet including one from Rabbi Brickner. I would hate to have the council and the community think that he is representing our community because he certainly doesn't represent me and many I have spoken to. A month or two ago when this first came up and the Temple Israel board voted to oppose the proposal, I conveyed that information to Mayor Spencer but I was under the impression that the board of directors was also going to follow up and send a letter to the city council members stating the position of the Temple. You know what they say about assuming and perhaps we could have coordinated that better but there is still time to act. As we discussed, this weekend is the time to send such a letter from the board to all of the council members and even encourage Temple members of like mind to send emails to all of the council members (and the city clerk) as well. I think the council members might be persuaded to oppose the proposal if they get enough letters in opposition and understand that there are community members that strongly oppose it. At this moment, there are no letters in opposition. It would also be helpful for those that can to come to the council meeting on Tuesday. It only takes 3 council members to approve it. For your information, I will send you a draft of the letter I am working on once it is completed and perhaps with enough of a response we can stop this.

My main concern is that when the chief proponent of the sister city proposal, Rev, Michael Yoshi, uses inflammatory language like Israel being responsible for the "theft of 94% of their land" and the "strangling" of their economy, it is less about building bridges of understanding and more about giving Israel bashers another platform for their propaganda. I will talk to you over the weekend. Please encourage those you know to send e-mails to the council members by Monday to be sure the council members see them.

The Sister City program is a partnership between the City of Alameda and the Ala Association (ASCA), a 501(c)3 non-profit organization established in 2009. Prior Cities program was facilitated by the Social Services Human Relations Board (S workgroup. ASCA evaluates and recommends new Sister Cities for add representative of the City of Alameda, organizes and supports all Sister City a fundraising and cultural events, economic exchanges, delegation visits, and hu among other initiatives. The relationship between Wadi Foquin and the Alameda community began in 200 Vista United Methodist Church (the "Buena Vista UMC") established a partnersh In 2015, the Buena Vista UMC hosted Mr. Ahmad Sokar, the Mayor of Wadi H Alameda and the Bay Area, and he expressed an interest in developing a Sist with the City of Alameda. In 2016, Mayor Sokar again visited Alameda. At that Councilmembers Matarrese and Ashcraft, as well as members of the ASCA B 2016, Ata Manasra, Coordinator for the Narjes Community Development project the Youth Development Coordinator, also visited Alameda and met with ASCA B the September 19th, 2017 City Council Meeting, Mr. Manasra was introduced during oral communications.

In October of 2016, ASCA approved the formation of the Wadi Foquin Sister City (by the Reverend Michael Yoshii of the Buena Vista UMC. Additional Committee Suzanne Yoshii, Paula Rainey, Austin Tam, Michi Yoshii, Judy Tam, Binh Nguye Cynthia Bonta.

In February of 2017, ASCA recommended the adoption of three new Sister Cir South Korea, Wadi Foquin in the Palestinian Territories, and Varazze in Italy relationship with Yeongdong was considered to be the most developed of the thr Cities, and the ASCA recommendation to adopt Yeongdong as a Sister City was to be forwarded to City Council. - Opportunity: Opportunities for mutually beneficial cultural, eco humanitarian and educational exchanges and program activities betwee based organizations.
- Financial Resources: Adequate financial resources or fundrais program activities, cultural exchanges, and maintenance of the relation

Reverend Michael Yoshii has indicated that officials from Wadi Foquin, including Mr. Manasra, are prepared to visit the City of Alameda in the spring of 2018. Base visit, and their adherence to the criteria described above, the Wadi Foquin Sis has asked that the Sister City relationship with Wadi Foquin be forwarded to approval, so that the relationship can be formalized during this visit through Memorandum of Understanding (MOU) (Exhibit 1). Tonight's action is the next st Sister City relationship with Wadi Foquin.

DISCUSSION

Wadi Foquin is located approximately five miles south of Bethlehem, in the Pales lies in a rich agricultural valley on the Green Line - the Israel-Palestinian B population of approximately of 1,300 people. Wadi Foquin is known for its natu agriculture, including olive trees, honey, fruits and vegetables.

The Buena Vista UMC has worked actively with the people of Wadi Foquin since of promoting economic prosperity in the village. Projects have included the fundir of bee hives to enable the production and sale of honey; a Youth Leadership y village youth the skills to succeed in a changing economy; and a Women's Initiati women of Wadi Foquin to harvest and sell honey, and sell hand-embroidered go the village. The Buena Vista UMC was also instrumental in the creation of a Center, which hosts these community programs and acts as a gathering space for recently, the Buena Vista UMC worked to re-sod a soccer field in the village. The also organizes annual educational trips to Wadi Foquin.

The Wadi Foquin Sister City Committee has stated that the goals of a Sister between Alameda and Wadi Foquin would be to develop people-to-people relaopportunities for education and cultural exchange, and to continue to support projethat promote the sustainability of daily life in the village. Potential projects idea Foquin Sister City Committee include the completion of the sodding of the soccel and ongoing support for the soccer activities; making improvements in roads naming one after the City of Alameda); facilitating student exchange; establishin village to support both local and international tourism; and hosting delegations Foquin. These proposed Sister City activities will be refined and finalized in cor ASCA and representatives from Wadi Foquin, and the Wadi Foquin Sister City responsible for planning and implementing all program activities.

Based on its adherence to the Sister City criteria described above, including mutually beneficial activities and the formation and ongoing commitment of the City Committee, as well as the support of Sister Cities International, as demonstrated to f support, ASCA has evaluated Wadi Foquin and recommended it be a City. As a result, staff is moving forward ASCA's recommendation that City resolution authorizing the Mayor to sign an MOU regarding formulation and imple City relations between Alameda and Wadi Foquin.

In addition to establishing formal Sister City relations, the proposed MOU call promote visits between their people and encourage exchanges in the fields of exchange, and the development of person-to-person relationships. The MOU a Alameda Sister City Association as the City Council's designee responsible f implementing the friendly exchange and cooperation programs between the two out the day-to-day work of a Sister City relationship.

FINANCIAL IMPACT

City funds in the amount of \$10,000 per fiscal year have been budgeted for maintenance of Sister City relationships.

Dear Mayor Herrera Spencer,

It is a pleasure to e-meet you, and I hope we can meet in person soon.

Thank you for reaching out to us about the topic of Wadi Fouqin, and explore about our approach to the matter. Here are some points that I believe should be considered by the city of Alameda before deciding on the matter:

1. Wadi fouqin is a tiny Palestinian village of around 1,000 people. The village has some zoning claims that go back many years and have been and still are considered by judicial authorities in Israel (you can see below some information on the matter).

2. In reality, this village has become in the last few years "the poster village" of anti-Israeli propaganda. A narrative of zoning claims is promoted by groups around the world. In our view, this narrative is shallow, fraudulent and deliberately misleading.

3. It seems to us that judging by the community activists promoting the sister city agreement, and our knowledge of the matter, that the reasoning behind creating the sister city, has nothing to do with actual exchange, but it will be used only for political purposes, in order to promote a political agenda.

4. It is obviously for the city of Alameda to determine its policy, but the middle east peace process is a topic of great complexity and nuances, and the US itself has a policy towards it. The city of Alameda should ask itself weather it needs to act in a manner that reflects a very clear political view in support of one side, one narrative. Is it the goal of municipalities to take stand on international affairs?. This topic is extremely complex, and I feel that the discussion at city level is not knowledgeable enough to bring about a good decision making.

5. Further, since the proposal is promoted by self declared BDS (A movement calling for the boycott, divestment and sanctions against Israel) activists, we can assume that the sister city agreement will be used to promote BDS activity in the future, under municipal hospices. This might even be against California law, and I would direct you to California bill 2844 (https://leginfo.legislature.ca.gov/faces/billNavClient.xhtml?bill_id=201520160AB2844)

6. Another issue that is worth considering is that BDS activity many times contains antisemite Components, and many times creates an atmosphere that is hostile to jews. This is something that is probably the most disturbing to us, and we worry when municipal bodies are uses in that manner.

I hope these points will help when discussion the matter this evening. All the best, Ravit Baer, We understand that you've recently heard from residents of the Wadi Foquin Village. We are glad you're interested in our region, and we would like to add additional context to the narrative presented to you. In all matters regarding the contested area near Wadi Foquin, the Israeli government's involvement there was to enforce the law whenever and wherever it was violated. Even if you consider this to be disputed land you must recognize the need for law and order and all activity by Israeli forces in that area was carried out in order to uphold the law.

In September 2014, a 1000 Dunam (245 Acres) near the Wadi Foquin village, but outside its borders and without no known private ownership, was declared Israeli State Land after a thorough examination of the area using satellite imagery—a process which is used commonly to determine borders. After any such declaration, those who wish to protest have the option to submit an appeal for review. Such appeals for this plot of land have been submitted and are under legal deliberation at this time. Residents of Wadi Foquin bypassed the legal appeal process and proceeded to illegally plant saplings in that plot of land. To make room for these saplings, the residents uprooted and destroyed 70 old oak trees which were part of the natural landscape and are considered a protected species making them illegal to destroy. Israeli law enforcement understandably became involved after these incidents which violated multiple laws.

Furthermore, the soccer field erected near Wadi Foquin was built at a time when an injunction against any such construction was in effect. Additionally, the land selected by Wadi Foquin residents for this soccer field is over a kilometer away from the village and outside the approved and established boundaries of the village.

This declaration of state land was applied to land which was raw, unprocessed, and uncultivated. There are no known documents to support ownership claims of the land by the residents of Wadi Foquin. While Israel is acting within the law, the residents of Wadi Foquin are violating it. Again, there is an ongoing appeal process. If that process determines that the land belongs to Wadi Foquin then they will be able to plant saplings and build a soccer field there. The Israeli government simply requests that the residents of Wadi Foquin act within the boundaries of the law. Unfortunately, the residents of this village are constantly being used by their leader to create provocations towards the Israeli authorities. No international law can allow this uninhibited breach of any law.

Dear Honorable Mayor Spencer and Councilmembers Ashcraft, Matarese, Oddie, and Vella,

I am a member of Temple Israel of Alameda's Board of Directors, and I write in strong opposition to the City of Alameda proposal to grant sister city status to Wadi Foquin.

On September 12, 2017, the Temple Israel Board of Directors voted in opposition of granting Sister City status to Wadi Foquin. This decision was made as we reviewed the chief proponent of the sister city proposal, Rev. Michael Yoshii, and his use of inflammatory language in the press of Israel being responsible for the "theft of 94% of their land" and the "strangling" of their economy. It is less about building bridges of understanding and more about giving Israel antagonists another platform for their propaganda. Although his humanitarian efforts are laudable, his inflammatory political rhetoric ignores the historical realities that have made this conflict so long, difficult, and complex as it is contrary to the objective of building bridges of understanding and cooperation. The sister city initiative appears to be a political move versus building cultural and commercial ties as is the definition of being a "sister city."

In researching sister cities, I learned that a sister city has similar local and geographic characteristics. This definition harkens back to President Eisenhower's articulation of the term. Two of the three current City of Alameda sister cities are coastal cities while the third is situated on an island with thriving populations and commerce from which Alameda can benefit culturally and commercially. However, Alameda and Wadi

Foquin have nothing in common with respect to local and geographic characteristics. Wadi Foquin is located in a desert, it is entirely inland, and it is a small agrarian society. Alameda bears none of those characteristics.

In understanding the needs of Wadi Foquin, our former Rabbi Allen Bennett recently visited the village and provided his first-hand impressions. Yes, the villagers petitioned the Israeli government to return to their farmland to continue with their peaceful lives. The villagers accepted the fact that the Israeli government would provide them 10% of land to farm. Once settled and crops harvested, the villagers had problems getting their produce to market because of the "security checkpoints." Rabbi Bennett was instrumental in arranging a regular farmers market for the villagers to market their produce. Rabbi Bennett learned that the people of Wadi Foquin would like nothing more than to grow their crops, educate their children, and live in peace. The villagers of Wadi Foquin have been pawns caught in the middle of the Israeli-Palestinian conflict for decades. On the other hand, there are Israelis, too, who would like to live in peace and raise their children. However, Israelis are under constant vigilance with the real possibility that their families can be destroyed by someone who was taught to hate Jews from an early age.

One point worth making is that the situation that exists in the Middle East is a complex one and it is not productive to vilify one side without a sincere attempt to understand the complexities that led to that point. That certainly doesn't justify bad behavior on the part of the Israelis or the threat, and worse, inflicted on the Israelis from their neighbors. Most can agree that these people are neighbors and would benefit from finding a way to live in peace. We have no doubt that

many Israelis and their neighbors would much prefer open fields and roads between them rather than walls and security posts, but what has necessitated such security?

Additional points considered resulting in our opposition of this initiative:

• Although we are all in favor of progressive and economic relations with any community, Palestinian or otherwise, the position of the Buena Vista Methodist Church indicates an interest in a very one-sided platform, considering only the Palestinian propaganda of an unfair political fight.

• By creating this association only with a Palestinian city, advocating for the destruction of the only Jewish State in the world, Alameda sends a very one-sided and destructive message.

• Temple Israel of Alameda's Board and congregation strongly advocates for sister city relationships with Palestinian, as well as with Israeli cities, without supporting the animus that exists between these two communities. This proposed relationship only advocates for half the story. As Alamedans, we must advocate for the truth, and not take up only one side of this political quagmire.

Please note that, although former Temple Israel Rabbi Brickner approved the idea of a sister city relationship on this issue, he did so as an Alameda resident, not as a representative of our congregation. His association with Temple Israel ended on June 30, 2017.

I strongly recommend the City Council votes no on this initiative or pull the agenda item from the consent calendar for further research and deeper discussion as there are very intricate complexities which need to be thoroughly vetted and understood. Thank you.

Dear City Council Members,

I am the former rabbi of Temple Israel of Alameda, serving there from 1996 to 2012. During my tenure at the Temple, I led several interfaith tours to Israel in addition to taking some personal trips there as well. On one of my personal trips I had the opportunity to visit, tour, and learn extensively about Wadi Fuquin, the village in the Territories that is now a candidate for sister city status with Alameda. Rather than meeting with the Mayor on that trip, I was hosted by the sheikh of the village, the religious elder of the community, who walked me through the entire area, teaching me about the unique history of the village, from ancient times up to the (then) present moment.

It was there and then that I learned how challenging it had become to get the village's legendary produce to market in Israel proper. I had seen the remarkable quality of their produce and thought it was a shame for them to be unable to sell it profitably. As luck would have it, I happened to know the rabbi in the community immediately to the west of, and directly above, the village, and called her on the spot to ask if their community could become a market for the goods from Wadi Fuquin. Within hours they had set up a communication channel which enabled the two neighboring communities to have a regular farmers' market and for both communities to profit from the experience. That farmers' market continues to this day.

This village seems to be nothing special. But looks are deceiving. The residents here have been displaced/expelled at least once, if not twice, and have petitioned the Israeli government to be able to return to their homes and farmland. Despite the Israeli government's reluctance to readmit them, in the end the government found no reason whatsoever that they should not be allowed to return to their homes, their land, and their lives. Although the land to which they returned was only 10% of the land they had left, they still came back happily and resumed farming.

These are farmers who have no particular political interest. Their interest, as they explained to me over and over again, is to be able to farm their land, sell their produce, educate their children, and live in peace.

While I do not see a great economic gain for the city of Alameda if you were to "adopt" Wadi Fuquin, what I <u>do</u> see is a recognition of the simple humanity of a group of people in that village who seek nothing more than to raise their families and live in their homes in peace. Their lives are not easy, and with the political situation unfolding around them, they are not sure what the future will hold for them. But I know for a certainty that they would be honored to be a sister city to a place that would acknowledge them and their humanity, would care about them, and would welcome cultural exchanges whenever possible. It seems to be a win-win situation.

I hope you will consider this letter of support favorably.

youth and children in active participation. Our children have so much to teach us about love.

I was happy that a medical mission to Dumaguete was the first project Alameda was able to bring to our sister city. It was a pure service of

love. What a first gesture of peace and love like no other. Alameda should be forever grateful to Alamedans: Cathy Nielsen and Dr. Maria

Araceli de Guzman, for arranging to bring the Philippine Medical Society of Northern California Medical Mission to Dumaguete in 2017.

But the story does not end there. My grand daughter, Malaya Sumii (5th Grade), heard all my stories of miracles that involved babies and children and wanted to go on the next mission. She has been planning for a whole year now for the medical mission to the Philippines, saving up for cost of transportation, hotel, and food. She has set aside a bagful of stuffed animals for gifts. She was assigned to be mentored by a Dentist as she requested. and will be rotated to surgery, and others. She will be attending two days of classes at the same Elementary School I attended. This was her idea to be able to come back to her own class to talk about what was different as well as what was alike about school in Dumaguete. What her Alameda class can learn from the Dumaguete Class and what ideas she can share with the Dumaguete children. She also is offering her messenger services to our Penpal Exchange Project at Encinal 6th Grade to carry letters to Dumaguete.

Our Sister City program between Alameda and Jiangyin, Dumaguete, Yeong Dong, and now Wadi Foquin - and soon after, Varazze, Italy is to benefit our youth and our children to know what it is like to live in another country, in another culture. Our courageous attempts at building peace cannot be tainted with anything political. We will surely fail, in that case.

We have already established the ASCA Planning Team for our 2020 International Youth Peace Conference. It will gather high school youths from our sister cities to our city of Alameda to provide opportunities to practice respect, trust, openness, understanding, acceptance, cooperation. The youth from Wadi Foquin will have experiences to share that will enrich not only our Alameda youth but all our sister city youths. Alameda already has a large community of support for Wadi Foquin,

by being a sister city, they are responding to the SCI call to U.S. cities to create sister city relationships with Palestine. Wadi Foquin's youth should also benefit from the experience of living in peace with other youths.

Please keep our youth and children in mind. They have so much to teach us about love and peace. We all need to learn how to be peacemakers especially in our present world of incessant conflicts.

This is in response to your request for an opinion regarding the sequencing of the City Council's consideration for establishing Varazze and Wadi Foquin as Alameda sister cities. The ASCA board believes that it is the prerogative of the City to determine when and if such resolutions may be presented to and acted upon by the Council, but in the spirit of cooperation, we offer the following suggestions:

1. Simultaneously place one resolution to establish Varazze as a sister city AND place another resolution to establish Wadi Foquin as a sister city on the same consent calendar before the end of 2017,

and

2. On a multiple fiscal year(s) basis, dramatically extend the timeframes for the follow-up formalization process including preparing MOUs, MOAs, purchasing gifts and decor, planning delegation visits and implementing operational programs.

You have previously informed us that the City's interest in presenting one city at a time is necessitated by the limitations and/or the absence of funds available to accomplish the many steps associated with formalizing and celebrating each union. Our above referenced suggestion to greatly extend the timeframes for the execution of these formalization steps, will spread the cost to the City over more than one year, and allows ASCA time to fund-raise in order to meet our own as well as some portion of the City's funding challenges.

Inasmuch as we have tried to provide a constructive, practical and positive response to what we believe is a serious financial obstacle for the City and for ASCA as partners, we hope that the City can understand an equally challenging and long-term situation ASCA faces regarding your request to choose an order. The long-term health and success of our sister city relationships with Alameda, with ASCA, with members of our Alameda communities, and with each other is based upon respect, trust and mutual cooperation.

The internal discussion that we have had over the past several weeks and months in trying to determine which city and committee goes first, has consumed a huge amount of time and has pitted ASCA members and committee members against one another. This competition is just the opposite of what we are striving to do, and we are determined not normalize nor to make acceptable this manner of engagement with one another.

This discussion has also elicited, from both committees, that they have each invested a lot of time, effort and resources, developing and nurturing trust and a cooperative relationship with both prospective sister city mayors and council members. To push the initial vote for sister city hood back for either committee would be to lose the considerable energy and inertia that has been built up, and discourage a whole group of very active Alamedans that support and make up the affected committee, as well as the rest of us in ASCA.

We hope that you reconsider and put enabling resolutions recognizing both cities as sister cities on the same agenda.

Dear Honorable Mayor Spencer, Councilmember Vella, Councilmember Oddie, Councilmember Matarrese, and Councilmember Ezzy Ashcraft,

As President of Temple Israel, I am writing you to convey our strong opposition to the City of Alameda granting sister city status to Wadi Foquin and urge you to vote no on this proposal.

On September 12, 2017, the Temple Israel Board of Directors voted in opposition of granting Sister City status to Wadi Foquin. This decision was made as we reviewed the chief proponent of the sister city proposal, Rev. Michael Yoshii, use of inflammatory language in the press of Israel being responsible for the "theft of 94% of their land" and the "strangling" of their economy, it is less about building bridges of understanding and more about giving Israel antagonizers another platform for their propaganda. His humanitarian efforts are laudable; however, his inflammatory political rhetoric ignores the historical realities that have made this conflict so long, difficult, and complex as it is contrary to the objective of building bridges of understanding. The sister city initiative appears to be a political move versus building cultural and commercial ties as is the definition of being a "sister city".

By all intents and purposes, a sister city has similar local and geographic characteristics. Two of the three current City of Alameda sister cities are coastal cities while the third is situated on an island with thriving populations and commerce from which Alameda can benefit culturally and commercially. When comparing Alameda and Wadi Foquin, there are no similar characteristics as they are situated in the desert, inland and is an small agrarian society.

In understanding the needs of Wadi Foquin, our former Rabbi Allen Bennett recently visited the village and provided his first-hand impressions. Yes, the villagers petitioned the Israeli government to return to their farmland to continue with their peaceful lives. The villagers accepted the fact that the Israeli government would provide them 10% of land to farm. Once settled and crops harvested, the villagers had problems getting their produce to market because of the "security checkpoints". Rabbi Bennett was instrumental in arranging a regular farmers market for the villagers to market their produce. *Rabbi Bennett learned that the people of Wadi Foquin would like nothing more than to grow their crops, educate their children, and live in peace*. The villagers of Wadi Foquin have been pawns caught in the middle of the Israeli-Palestinian conflict for decades. On the other hand, there are Israelis, too, who would like to live in peace and raise their children; however, Israelis are under constant vigilance with the real possibility that their families can be blown to bits by someone who was taught to hate Jews from an early age.

One point worth making is that the situation that exists in the Middle East is a complex one and it is not productive to vilify one side without a sincere attempt to understand the complexities that led to that point. That certainly doesn't justify bad behavior on the part of the Israelis or the threat, and worse, inflicted on the Israelis from their neighbors. Most can agree that these people are neighbors and would benefit from finding a way to live in peace. We have no doubt that many Israelis and their neighbors would much prefer

open fields and roads between them rather than walls and security posts, but what has necessitated such security?

Additional points considered resulting in our opposition of this initiative:

- Although we are all in favor of progressive and economic relations with any community, Palestinian or otherwise, the position of the Buena Vista Methodist Church indicates an interest in a very one-sided platform, considering only the Palestinian propaganda of an unfair political fight.
- By creating this association only with a Palestinian city, advocating for the destruction of the only Jewish State in the world, Alameda sends a very one-sided and destructive message.
- Temple Israel of Alameda's board and congregation strongly advocates for sister city relationships with Palestinian, as well as with Israeli cities, without supporting the animus that exists between these two communities. This proposed relationship only advocates for half the story. As Alamedans, we must advocate for the truth, and not take up only one side of this political quagmire.

As a note, although Rabbi Brickner communicated his approval of a sister city relationship, he did so as an Alameda resident not as a representative of our congregation. His association with Temple Israel ended on June 30, 2017.

May I mention

, it was on August 18, 2017 when our whole Alameda community and our Mayor and Councilmembers stood together against hate after our synagogue was the target of a hate crime. Let's stand together on th is

issue at-hand, please.

In closing, we strongly recommend the City Council votes **no** on this initiative or pulls the agenda item from the consent calendar for further research and deeper discussion as there are very intricate complexities which need to be thoroughly vetted and understood. However, should the initiative pass, we strongly recommend that the City Council monitor the sister city activities extremely closely, so the relationship remains honorable; emphasizing positive moves to maintaining peace; for the villagers to accept diversity amongst all who live there; educate their children to accept diversity and embrace their Jewish/Israeli neighbors; and the relationship to exist NOT for political reasons that further divide the Israelis and Palestinians or bash Israel.

Dear Mayor Spencer, Vice Mayor Vella, Council Member Ashcraft, Council Member Matarrese, and Council Member Oddie,

My family and I just learned that the Alameda City Council will be considering a proposal to declare the West Bank village of Wadi Foquin a sister city. This proposal is being put forward by Reverend Michael Yoshii of the Buena Vista United Methodist Church.

The United Methodist Church has stated policies towards Israel, that while on the surface may seem to be based on social justice, have deeply problematic repercussions. Most notable is the demand that Israel withdraw to the 1948 ceasefire line, which would leave the holiest sites of the Jewish faith inaccessible to Jews, as they were during the Jordanian occupation of 1948 – 1967.

Reverend Yoshii himself is a former Co-Chair of the United Methodists for Kairos Response, a group active in the Boycott, Divest and Sanction (BDS) movement, which the Anti-Defamation League recognizes as anti-Semitic. (see link below) Omar Barghouti, co-founder of the BDS movement, has said "No Palestinian will ever accept a Jewish state in Palestine."

As much as the intent of Reverend Yoshii may be peace, the BDS movement is linked to increases in anti-Semitic incidents – an April 2017 study by the Amcha Initiative shows a direct correlation between BDS activities and increased incidents of anti-Semitism on US college campuses. (see link below)

There are already problems with anti-Semitism in Alameda, as seen with the vandalism of Temple Israel and the repeated anti-Semitic incidents in our schools. As you may remember, our daughter Natasha spoke to the city council in September about her struggles with anti-Semitism in our school district. She has been victim of multiple anti-Semitic threats, and subjected to other anti-Semitic incidents. In the past two weeks of school, Natasha has discovered multiple swastikas and other anti-Semitic graffiti. Today, on the walk home from school, she saw a swastika in the sidewalk near the corner of Encinal and Walnut.

Beyond that, it seems that this resolution is largely being pushed by Reverend Yoshii and the Buena Vista United Methodist Church. It is not appropriate for the city government to be acting on what is essentially the doctrine of a single Church.

This is an extremely controversial issue and the city council should not be taking a stance. We don't need another excuse for anti-Semitism in our city. I urge you, if only for the sake of our family, not to support this resolution.

I am writing to you to convey my strong opposition to the City of Alameda granting sister city status to Wadi Foquin and urge you to vote no on this proposal.

When I first heard of this proposal, I made the Temple Israel of Alameda board aware of it and asked them to take a position on it. Despite the fact that our former rabbi, Rabbi Brickner, wrote a letter in support of the proposal, I was pleased to learn the board representing the Temple community voted to oppose it. You will be getting a letter in opposition from them shortly. Rabbi Brickner was expressing his own personal opinion and certainly doesn't represent me in this regard nor many of the people in the community I have spoken to.

As a member of the American and Alameda Jewish communities I have had a keen interest in our hopes and prayers for the citizens of Israel and its neighbors to find a way to live in peace. Many Arabs and Jews want only to live a good life and raise their children in peace but the obstacles to peace are complex.

With the people of Israel surrounded by many neighbors that don't even acknowledge their right to exist and some even advocating for their extermination (again), that is hardly an environment conducive to living in harmony. If your neighbors set off bombs in public places like on busses and in restaurants, fire rockets from adjacent territories, teach their children hate, and even deny your right to exist, it is no wonder that such tension exists in the region.

One of my main concerns is that when the chief proponent of the sister city proposal, Rev. Michael Yoshi, uses inflammatory language in the press like Israel being responsible for the "theft of 94% of their land" and the "strangling" of their economy, it is less about building bridges of understanding and more about giving Israel bashers another platform for their propaganda. His humanitarian efforts are laudable, however, his inflammatory political rhetoric ignores the historical realities that have made this conflict so long and difficult and is contrary to the objective of building bridges of understanding.

Rather than bringing people together at a time when our on society is already too divided, I suspect that if this action is approved, it will only exacerbate those feelings of division.

It is ironic that some of our political leaders that came together to support the Jewish community after some recent anti-Semitic attacks are now considering an action that is contrary to the interest of that community.

I urge you to vote NO on the proposal to make Wadi Foquin a sister city of Alameda.

It has come to my attention that you are considering a proposal for the City of Alameda to become a sister city to Wadi Foquin, in Palestine. I believe this proposal to be a mistake. By extending sister-city status to a Palestinian city, it appears that the government of the City of Alameda is making a political decision to support Palestine over Israel. While individually, as private citizens, you are all of course entitled to your own opinions on the Israeli-Palestinian conflict, but as the city leaders, it should not seem to our citizens that one side is favored over the other by our government.

You are aware that anti-Semitism has been cropping up more frequently in our city, as well as in the rest of the country. Adopting a Palestinian city as a sister city is likely to further embolden the anti-Semites in our community. After the hate crime perpetrated at Temple Israel, the Jewish citizens of our city were heartened by the show of support from the rest of the community. Adopting as a sister city a municipality that is dedicated to eradicating Jews from the earth could be seen as a message to the Jewish community of Alameda that we are not welcome or wanted here.

Please consider carefully all the ramifications of this sister city proposal before making a decision. This is more than just exchanging certificates and perhaps making a visit to an exotic locale. There is a deeper message involved here.

Dear City Council,

Greetings from the Sultanate of Oman which I am visiting after a conference in the United Arab Emirates. Although I am Jewish, you can tell that I have no problem working or talking with Arabs per se. I have done so for over 40 years. Many Arabs, however, do have a problem with Jews and Israel as one can see every day by reading the local press articles in English. Most of what they write is based in fact but are usually half truths. One such article this past week spoke about the corruption of the Israeli government. While that was true, the same article conveniently neglected to mention that Israel is a society of laws where corrupt politicians have been jailed and that before criticizing others, Arab societies should ask what would happen if they raised the same charges against their own leaders.

My very open-minded and world-travelled tour driver today told me that when he was in school 20 years ago, the Omani curriculum taught him that Jews are money-grubbing leaches who shoot Arabs and are totally untrustworthy. And this in one of the world's more liberal Arab countries. He is unaware of what current Omani students are being taught. However, mountains of documentary evidence shows that the Palestinian public school curriculum follows similar trends. For example, a math problem would ask, "If our martyrs ambushed ten Israeli soldiers and killed seven, how many Zionist pigs would remain alive for future confrontations?".

As do many liberal Jews, I totally support an independent Palestinian state and abhor Israel's settlement policies and land grabs. I totally and personally empathize with Palestinian anger at the daily frustrations and humiliations many endure. However, after 50 years of occupation, two intifadas, and Israeli offers of a political resolution in 2000 and 2003 and beyond, the status quo remains. The issue ultimately becomes whether more of the same actions will generate a transformation or whether other, totally different alternatives can achieve the independence Palestinians seek.

Ultimately, the Palestinians focus on decades of injustices and Israelis focus on decades of insecurities. Both viewpoints are valid but a resolution can only start when both sides recognize the validity of the other's realities ... and change their behaviors.

I greatly applaud Buena Vista UMC's and Wadi Foquin's mutual efforts to improve that town's economic well-being. Those are critical steps to create prosperity and break the cycle. BUT no where does the resolution show Wadi Foquin's political actions.

To bestow the gift of a sister-city relationship, the Alameda Council should first ask what visionary, moral leadership Wadi Foquin's city council has demonstrated. Is Wadi Foquin taking a transformational path as Gandhi would have done? Or are they simply perpetuating Arab half-truths, lies and lsrael-bashing? Are the town's schools and newspapers a mouthpiece for continued negativity? Or do they foster mutual understanding? What courage and leadership has its council shown to demonstrate a positive way out of the impasse? Or is WF's council perpetuating the Palestinian party line? **If you do not know, it is best to table your decision until you can find out.**

In general, Muslims and Arabs want the rest of the world to understand them but they do not seek to understand the world. And in Arab societies, questioning can be dangerous. With Israel-Palestine, you are not dealing with a simple, uncharged relationship as with Korea and the Philippines. <u>Nice ceremonies and people-to-people exchanges in this case show legitimacy, not dismay.</u> If Alameda City Council is not going to postpone a decision or refuses to take additional, costly actions to help Wadi Foquin break its ingrained mindset, I suggest that you deny this relationship.
