With great enthusiasm, Centro Legal de la Raza (Centro Legal) submits this proposal to serve as the legal services provider concerning the City of Alameda Rent Program. Founded in 1969, Centro Legal has been a cornerstone of justice for almost 50 years. Centro Legal provides culturally sensitive direct legal aid to over 7,000 low-income individuals throughout Northern California annually in the areas of housing, workers' rights, and immigration. These programs foster equity, stability, and economic prosperity. Centro Legal provides services to all low-income individuals regardless of citizenship status.

Centro Legal has extensive experience working collaboratively with partner organizations and local government to provide critical services in Oakland, the Bay Area, and California. Just this year, Centro Legal established a new partnership with the County of Alameda to serve as the County's lead agency for the Anti Displacement Crisis and Intervention Program. Through this most recent partnership, we have implemented a "No Wrong Door" policy by creating a full service hub that includes East Bay Community Law Center, Bay Area Legal Aid, Housing and Economic Rights Unit, and Eviction Defense Center. This full service hub provides all Alameda County tenants with a unique, innovative, and client centered approach to obtaining legal services through our peer-to-peer referral (P2P) system. This new system allows all agencies within the hub to find and refer any given tenant to the right legal services provider who will then be able to assist them with their specific housing issue. We now hope to increase additional capacity to serve tenants from the City of Alameda.

In the previous year, Centro Legal's Housing Program has provided over 3,000 legal consultations to 1,141 individual client households to low-income tenants living in Alameda County. Just in the past year alone, we have represented 82 households in landlord/tenant disputes and prevented loss of current housing for 33 households.

## **II.** Organization Information

Founded in 1969, Centro Legal has been a cornerstone of justice for almost 50 years. Centro Legal provides culturally sensitive direct legal aid to thousands of lowincome individuals throughout Northern California annually in the areas of housing, workers' rights, and immigration. These programs foster equity, stability, and economic prosperity. Our legal services are available to all low-income individuals regardless of citizenship status. In the previous year, Centro Legal's Housing Program has provided over 3,000 legal consultations to low-income tenants residing in Oakland, Hayward, and Richmond in cases involving evictions, substandard housing conditions, and rent disputes. Just last year, we also successfully represented tenants in landlord/tenant disputes in 82 cases recovering over \$422,000.00 on behalf of low-income tenants.

Furthermore, Centro Legal has extensive experience working collaboratively with partner organizations and state, county, and local governments to provide critical services in the Bay Area and California. Centro Legal's housing practice provides legal services pursuant to various government grants, including grants from the County of Alameda, and cities of Oakland, Hayward, and Richmond. Just this year, Centro Legal established a new partnership with the County of Alameda to serve as the County's lead agency and administrator for the Anti Displacement Crisis and Intervention Program.

## III. Service Approach

## a. Experience Providing Need-Based Legal Services to Tenants

Centro Legal de la Raza's Tenants' Rights Program ("Housing Program") focuses on ensuring stable, healthy housing for low-income renters. The program emphasizes the defense of tenancies of low-income tenants to curtail rampant displacement of long-term Alameda County residents.

Our "housing security" approach to providing need-based legal services seeks to maximize our impact in order to prevent the large-scale displacement of Alameda County tenants. We believe that this can be accomplished through full scope representation of low-income tenants in unlawful detainer (eviction) cases. Otherwise, there is a high risk that such cases will result in displacement and homelessness, if a tenant is forced to navigate the complicated and adversarial court system without an attorney.

Housing attorneys work to ensure enforcement of state and local laws by providing both full scope legal representation and limited scope legal consultations on the following issues: (1) eviction-related matters; (2) rent-related administrative hearings, including mediation for the cities of Hayward, Oakland, and Richmond; (3) general counseling on renters' rights; (4) limited scope assistance to renters; (5) assistance with small claims matters related to security deposits; and (6) public outreach and know-yourrights presentations.

For instance, in the context of a tenant who has received a Three Day Notice to Pay or Quit ("Notice"), a Centro Legal attorney will make an initial assessment of whether the Notice was lawfully served. Attorneys (or staff under attorney supervision) will advise the tenant and counsel the tenant on possible next steps (e.g. draft a letter to the landlord challenging the legality of the Notice) and ensure knowledge of the eviction process. For instance, where the tenant has not been paying the entire rent sought by the landlord, the Attorney will: (1) determine whether the tenant is behind on the rent; (2) determine whether the tenant has lawfully withheld rent and likelihood of success in an unlawful detainer proceeding, (4) determine whether the tenant qualifies for one-time rental assistance to avoid the filing of an unlawful detainer, through our Emergency Financial Assistance Program; and (5) assess whether the tenant can afford the housing in the long-term.

## b. Experience Providing Services to Diverse Populations

Centro Legal prioritizes the provision of bilingual, culturally sensitive legal services to monolingual Spanish speakers, as well as other Limited English Proficient (LEP) tenants, regardless of immigration status. Of the 1,141 new clients we saw in the past year: 816 individuals were living with a disability, 575 identified as Hispanic, 299 identified as Black/African American, and 298 individuals were LEP clients.

In addition to the diverse makeup of our client community, Centro Legal has extensive experience working collaboratively with partner organizations and local government to provide critical services in Oakland, the Bay Area, and Northern California. Our Housing Program staff thereby assist many different and overlapping underserved communities, with a wide range of linguistic and cultural needs, including the elderly, people of color, and those living with a disability. We also provide written material in various languages, to ensure clients and community members receive information in a way that is both accessible and culturally sensitive.

In addition to our large pool of staff who speak multiple languages and are bilingual/bicultural, we ensure access to our services in many different languages through interpretation services provided at no cost to the client. We also provide a fully accessible workspace, to welcome individuals living with disabilities and ensure that all tenants can obtain our services in a meaningful way.

## c. Experience and Ability to Respond to Time-Sensitive Matters as Required by the Alameda Rent Program

Presently, Centro Legal provides legal services to tenants of Richmond, Hayward, and Oakland through similar municipal funding. We have trained and experienced intake staff, housing advocates, and attorneys who regularly represent tenants in eviction matters and administrative hearings. Our intake process responds to the short time frames that tenants face when served with an eviction notice. Our office is conveniently located near the Fruitvale BART. We have ample parking and are accessible by bus from the City of Alameda.

### d. Key Personnel

The key personnel who will ensure the success of this project include: Monique Farris, Managing Attorney, and Jackie Zaneri, Staff Attorney. Ms. Farris has over 10 years of unlawful detainer experience. Ms. Farris also spent two and half years representing tenants in mediations at the Alameda County courthouse. Ms. Zaneri has spent several years representing tenants across the East Bay and is very familiar with the City of Alameda's tenant protections.

In addition to these key personnel, our Housing Program consists of four bilingual housing attorneys experienced in all aspects of landlord/tenant disputes, as well as numerous additional support staff.

## e. Needs Testing and Allocation of Legal Services

Centro Legal's established intake procedure enables the organization to ensure services are provided to low-income tenants living in its service areas. Prospective clients fill out intake forms so that staff can determine whether tenants qualify for services based on income. Centro Legal will assist tenants whose income meets the HUD Income Limits under the Community Development Block Grant Program, based on the median family income for the Alameda/Contra Costa Primary Metropolitan Statistical Area, which is currently \$97,400.00 for a family of four.

#### f. Experience Reporting for Service Delivery and Case Management

Centro Legal collects data related to eligible clients, services rendered, costs (by way of average cost per service type), and outcomes. Data collected includes: zip codes served, client age, client race, client ethnicity, client/household disability status, and household income. Centro Legal provides reports to funders on a monthly, quarterly, and annual basis, detailing the number of clients served and pertinent data regarding their tenancies and demographics. These reports have confidential client information redacted to preserve attorney-client privilege and in conformity with other applicable laws. Centro Legal maintains full client records at our offices.

#### **IV.** Fee Proposal

Centro Legal would require a budget of \$183,305.00 per 12 months of service to provide consultations for 100 tenants through our weekly brief service clinics, and represent tenants in 40 unlawful detainers and 4 mediation hearings. Centro Legal would hire an experienced attorney to create the necessary capacity to make these services available to City of Alameda tenants. All staff at Centro are bilingual Spanish-speakers and have access to interpreters for other languages as needed. The hourly rate for the attorney would be between \$250.00 and \$400.00, depending on years of experience.
