The Alameda Chamber of Commerce is proud to throw its full support behind the exciting proposal by the Residence Inn division of Marriott Hotels to build a 172-room hotel in Harbor Bay adjacent to the ferry building.

Alameda is severely lacking in upscale lodging for both business and personal travel. Additionally, there are very few conference and event spaces, presenting a constant challenge for the Chamber, local businesses, non-profit organizations and residents. The new hotel will feature enough conference space to accommodate 100 guests for business events, weddings or other private gatherings with a window view to the Bay. The hotel's convenient proximity to the Oakland Airport and Harbor Bay Ferry Terminal is ideal.

To complement the hotel, two dining options -- a free-standing waterfront restaurant, and a café—will benefit hotel guests, ferry riders, neighbors, and Shoreline Park users.

The Residence Inn by Marriott is expected to bring in \$1.5 million in additional tax revenue to the city each year, as well as dozens of well-paying, fulltime union jobs. The proposed site is large enough to easily accommodate the hotel and associated parking and is properly zoned near office buildings in the Harbor Bay Business Park.

This proposal is a win-win for the residents and businesses of Alameda. The Chamber and its members enthusiastically endorse the proposal and urge swift approval by city planners.

Dear Planning Board Members,

I am writing this letter to express opposition of the Final Development Plan and Design Review - New Five Story 172-Room Hotel and 8000 Sq. Ft. Restaurant with Coffee Shop, located at the Esplanade site.

We are requesting more time to have a dialogue with the planning board to express our concerns. The community of Harbor Bay Isle was only made aware of the proposal a couple of weeks ago and many of our neighbors were made aware of the proposal a few days ago. To have the matter considered right after a holiday, not even a month after most of the neighbors were made aware of the development, is not fair to the neighborhoods. As neighbors we have not been NIMBYs. We worked with Joe Earnst of SRM Ernst when he first developed the Esplanade plan. We worked with him to mitigate the negative impacts on our neighborhood. We did not as a community oppose the original project. When a retirement home was proposed, we also as a community did not oppose the project but wanted certain mitigations written down and made part of the proposal. This hotel project, however, is different. We believe this project will have a greater impact on our quality of life due to increased traffic, noise and public safety concerns. We also believe the project will have a negative impact on our property values. This is evidenced by neighbors that have been unable to sell their homes because potential buyers are being made aware of a hotel being built right next door to a residential neighborhood. We did not have this problem when it was revealed that an office building could be built right next to our neighborhood.

We recently had a community meeting where we invited the developer to present the plan. When he asked if anyone was in favor of a hotel on this site, no one raised their hand in support. There were about 60 homeowners present at the meeting. Regardless of what was being built on the site that did not conform to the original Esplanade plan, be it an office building or a hotel, we would want more time to review the proposed project and how we could work with the developer to mitigate the negative impacts on our neighborhoods. This hotel is a radical departure from the plan presented to us for the Esplanade and deserves a thorough review and discussion with the Planning Board and developer so that we as a community can make an informed decision that benefits all parties involved.

Hi Lara - I'm taking the time to write to you as my family is gravely worried about the proposed hotel adjacent to the Harbor Bay Ferry Terminal. As residents of the Bay Colony area, there are a few specific reasons for our concern including:

1. **Impact on traffic and safety in our residential area** - Building a 5-story hotel in a residential area feels highly inappropriate and completely out of sync with the surrounding neighborhood. The Bay Colony, Columbia, and Freeport areas are all residential areas where many families live with young children. Bringing a hotel to this area will undoubtedly increase traffic and bring many new strangers into our residential area. As parents of young children who actively play outdoors in the area, we're very concerned about risks to our kids' safety as many people unfamiliar with the area would now be out driving on our streets and walking through the neighborhoods.

2. **Impact on noise** - Unlike the office buildings built on adjacent lots, a hotel will create a huge amount of noise pollution. From frequent delivery vehicle visits to events hosted at the hotel to daily janitorial/room service for hundreds of rooms, hotels create a TON of noise that smaller office buildings do not. Importantly, hotels operate 7 days a week and 24 hours a day, meaning that there is little relief from the noise pollution. The office buildings that are located on adjacent lots are typically empty during the night/evening hours and on weekends (the times when most residents in Bay Farm are at home) making them feel much more appropriate for this area.

3. **Impact on the environment** - A 5 story hotel may also have deleterious effects on the local environment and habitat. A large 5-story structure will dominate the landscape, clash with the adjacent structures, and have an overall negative aesthetic impact on the area. Beyond the aesthetic impact, it would also be helpful to understand potential other impacts that this hotel would have on the environment. Appropriate time should be taken to fully understand any and all environmental impact that this giant facility could have on local ecology, animal habitats, the bay, and our beautiful coastline.

We certainly understand the desire to build on this vacant land, but a 5-story hotel definitely feels like an inappropriate use of the space and a material departure from the 1-2 story office buildings that have been built on the adjacent lots. As a result, we'd strongly urge that the City Planning Board NOT allow a hotel to be built at this location. We'd be happy to discuss and/or provide additional detail on any of the above concerns. My name is Velvet Chang and I am President of Bay Colony Homeowners Association. I am writing on behalf of the Board of the Bay Colony Homeowners Association. We are in opposition to the Final Development Plan and Design Review - Marriott Inn Alameda Five Story 172-Room Hotel with conference room, a 8000 Sq. Ft. restaurant and 270 parking spaces, located at the Esplanade site.

Bay Colony Homeowners Association has 108 homes located directly behind the Harbor Bay Ferry parking lot and the proposed site of the hotel complex. Bay Colony Homeowners Association was not notified of the proposed 5 story hotel project. The Bay Colony Board was made aware of the impending final review of the 5 story hotel project a few days ago at a Village 5 meeting. The Bay Colony Board is currently taking measures to notify all its homeowners of the proposed 5 story hotel project.

The proposed 5 story hotel complex is completely out of proportion to the land area and surrounding structures. The hotel will literally cast a shadow over the surrounding homes. Imagine taking in the sun in your back yard while hotel guests watch you, inhaling the exhaust from the going and coming of 265+ cars, smelling breakfast, lunch and dinner being cooked and the garbage and noise pollution. The 5 story hotel complex also poses public safety concerns of traffic, noise and pollution as well as criminal activities such as car break ins, prostitution and drug dealings.

The proposed 5 story hotel project has already negatively affected property values. Over 100 buyers viewed a Bay Colony home during a recent open house. Unfortunately our neighbor received no offers to buy when potential buyers were made aware that a hotel was being built behind the house.

This 5 story hotel project has far greater impact on Bay Colony Homeowners Association with its 108 homes and their families than previous proposals for the Esplanade. The final review of the 5 story hotel complex should not be made in haste without considering the serious impact on so many families. We need the opportunity to have our concerns and questions addressed by the developer and the Planning Board.

Having the final review of the 5 story hotel complex scheduled right after the Thanksgiving weekend is an effort to discourage attendance by concerned homeowners. Please delay the final review of the 5 story hotel project until all concerned and affected parties have had an opportunity to be heard.

To Whom It May Concern,

I am writing to OPPOSE the construction of the hotel complex by the Harbor Bay Ferry. I am a resident in Bay Colony since 1992, and have seen many transformations in the surrounding areas. From a business perspective, this sounds like a great opportunity. However this location was chosen poorly for this hotel and it will cause many issues for the surrounding neighborhoods. Please see the following list of issues:

- Increase in traffic we already have issues with non bay farm residents using our neighborhood for overflow parking for the ferry. On top of that, it is a challenge to get home after work due to the increase of traffic into bay farm and into my own neighborhood. We chose Alameda as our home for the peace and quiet. If you build a hotel, the number of traffic will increase. How would the city of Alameda mitigate the traffic issue? Nothing has been addressed since the multiple companies that moved into the business park or the increase of folks that come in to use the google/Facebook buses, or the Chinese school or to use the ferry.
- Noise and safety with the increase flow of people using the hotel and conference spaces, there will be an increase of noise at night. We already call bay farm security pretty frequently to control loiters hanging out in the ferry parking lot. Hotels run 24 hours a day so this will negatively impact us as residents. On the same note regarding the constant flow of people, safety will also be impacted. There are many families living in the surrounding areas and this will greatly decrease the level of safety. Is the hotel adding security? Is bay farm increasing security patrol in the area? How would you address the additional noise?
- Property tax living on bay farm is expensive and I work very hard to stay in this area. By building this hotel, my property value is going to decrease.

I strongly encourage you to oppose this proposal. I have been a resident of Alameda for quite some time and I can't imagine living in a better place . Please consider the concerns I listed above and decline this development. This is not a place to build a 5 story hotel.

Dear Planning Board Members,

We are Freeport homeowners of 15 years and I'm writing this letter opposing the Final Development Plan for the new five story, 172-room Marriott Hotel with the coffee shop/restaurant, located at the Esplanade Site. We did not receive any notice of this hotel coming across from our development until we where informed by our HOA.

We are asking if a study has been done on the impact to vehicle and pedestrian traffic coming into and out of our neighborhood. If a study has not been done, we are asking for one to be done. If a study has been done, will the City of Alameda be adding any traffic controls such as a four way stop signs at the corners of Sharon Road and Mecartney Road, Orr Road and Aughinbaugh Way, and traffic and pedestrian signals at Aughinbaugh Way and Mecartney Road. Since Alameda is a green city, numerous children and adults in the neighborhood ride their bikes to and from school. Even though the hours before and after school have high bicycle and pedestrian traffic, there are always many walking and riding bicycles on weekdays and weekends. In addition, there is already extremely heavy vehicle, bicycle, and pedestrian traffic due to the ferry.

With so many hotels coming into the business park and so many residences in the area, is there an emergency plan in place currently for evacuations. If so, how will this be impacted with additional hotels given that there are only two main exits routes out of Bay Farm Island on Doolittle Drive and Ron Cowan Pkwy?

Another issue of concern is how the air traffic from the Oakland Airport will be affected. Currently in bad weather, planes fly in very low to land at the airport directly over the Esplanade Site. A five story plus building (six stories with the elevator shaft) on the Esplanade Site would force the plains over our development given the runway designs. We know this based on the past experiences when the main runway that is inline with the Esplanade Site closes. If this development on the Esplanade Site is approved, will the City of Alameda provided windows in our development to reduce the increase noise pollution.

Lastly, is there away to ask for more time to talk over the communities concerns with the Alameda Planning Board and the city in general. We are not opposed to development in the Esplanade Site area, we would just like a chance to discuss our concerns about the scale of this project going into such a small footprint adjacent to Freeport.

I am writing in regards to the planning application PLN18-0381, 2900 Harbor Bay Parkway. I have reviewed the proposed plans and I know the site well, as I live in close proximity to the proposed building site. I wish to strongly object to this proposal of building a 5 story hotel at this location.

The Bayfarm community is a small, primarily residential neighborhood where development proposals should be considered very carefully. This proposal of building a 5 story hotel overtly conflicts with the existing aesthetic of the neighborhood, as most existing structures are currently 2-3 stories tall. If approved, this project will drastically alter the shoreline and skyline of the neighborhood and well as the character of the island. I am also significantly concerned that this development, if approved, would overwhelm the local infrastructure, as it would result in a significant increase in noise and traffic. Online, there is a big variety of photos of Marriott Residence Hotels in the Bay Area. They vary from the bland, uniform, boxy, really sort of cheap looking, to very nice "residential" architecture; interesting and welcoming.

1.I, and many other residents, think its very important that any Hotel in this sensitive, controversial area, next to residential homes, and the beloved and well used Shoreline Trail, incorporate a residential "feel". There will likely be more community acceptance and less objection if you go this residential architectural route rather than the boxy ofice style architectural route.

Please see the SF Marriott Residential Inn at Oyster Point and Fremont Silicon Valley Residential; San RamonResidential Inn as possible good looking examples.

Contrast that to the unform, boxy and cheap looking Residential Inn in Redwood City.

2. Sorry to be blunt, but many residents and walkers truly dislike the look of the McGuire Hester building

I thing it would be a big mistake to go for a similar office look.

3. 4 or 5 stories is way too high. The Esplanade zoning or plan is for 38 foot height limit.

4. Additionally, the Esplanade Plan calls for office buildings, not hotels.

5. I believe the entire Esplanade Plan calls for approximately 100,000 square feet for 10 office buildings. This Hotel alone calls for 113,000 square feet(?) If so, this is way too large for this sensitive area next to our beloved Shoreline Trail.

6. Yes, 35 foot setback is the minimum requirement. However, why should this City always go for the minimum? Given the size of the building, the City, the Planning Board should do the right thing and ask for larger setbacks on all sides with nice landscaping.

7. BCDC must be involved with this process, just like the former proposed hotel(Patel) was.

8.. I have heard that the Corica golf course management is interested in building a boutique hotel for the golf course which is being credited for PGA and will(hopefully) be attracting more golfers and people in the near future.

This golf course idea sounds quite interesting incorporating a boutique hotel with conference room on/near the golf course than attempting to wind customers through the ferry parking lot or through residential streets or the narrow Adelphian Way, to get to the Esplanade site. If the Golf Course is really interested in a hotel, what about putting the Marriott Residence Hotel near the Golf Course?

The City has done some unusual things in the past, like putting its jail on the South Shore beach. Perhaps, in the 21st century, locating a Marriott Hotel in a more central location may be ultimately more practical and profitable for everyone in the long term. Thank you,

His presentation involved PowerPoint oversized graphics of site plans and elevations, as well as handouts about the architectural features and the planned facilities and programs of a Residence Inn by Marriott, including a free-standing waterfront restaurant and a café and offering WETA 125 additional parking spaces for overflow ferry terminal parking.

I am writing in regard to project PLN18-0381-2900 Harbor Bay Parkway, Harbor Bay Hospitality, LLC. As a homeowner in the Freeport development of Harbor Bay, I recently attended a discussion session with Robert Leach of West River regarding the proposed Marriott's Residence Inn at Harbor Bay. After viewing the plans and listening to the discussion, I would like to register my opposition to the proposed hotel.

I am opposed to this project for several reasons:

- 1. It is overwhelmingly large compared to all other buildings in the area. It is not an attractive luxury hotel, but an unsightly business commuter hotel. It will not enhance the aesthetics or value of our neighborhood, only block the natural coastline and cheapen area.
- 2. It is already depressing our property values. Two homes on MacDonell have been unable to sell. One of the homeowners at the November 7 meeting told us despite giving out 13 disclosure packets, no one decided to make an offer, specifically because of this project.
- 3. The offer of ferry boat parking is disingenuous. Mr. Leach told us ferry boat riders will be able to pay for parking spots not being used by the hotel, but if the spaces fill up, there could be very little or no parking. There is no guarantee of any parking. If the city council is serious about improving the environment, they would use eminent domain to purchase some of the land and have dedicated ferry parking.
- 4. I am concerned about such a tall building directly in the flight path. We witness airplanes flying very low on a daily basis, but especially during rerouting for weather. Will more low flying airplanes be rerouted over our houses during inclement weather? Is the hotel offering too pay for soundproofing of our houses for increased noise pollution? Has Oakland Airport studied how this building will affect flights?
- 5. It will create a lot of additional traffic through our residential neighborhood where children are playing, walking and biking. It will create a lot of additional traffic on Harbor Bay Parkway, where our children walk and bike to Alameda Martial Arts and G9 AcademicsTutoring. Hundreds of guests, employees,

deliveries, shuttles and Ubers will be driving through our residential neighborhood 24 hours a day. There is already a problem exiting the Freeport development during Ferryboat arrival times.

Many residents were unaware of this project until recently. Most of us were told by our realtors when we purchased our homes that the parcel was zoned for two story office buildings with view corridors. We feel betrayed that we are now being told this is not true, and that this detrimental project is set to be approved only a few short weeks away, on the day after the Thanksgiving holiday, when many residents will be unable to attend. I sincerely ask that you vote no on this project.

These are my concerns. There will be a restaurant and conference rooms planned here. I am not opposed to a restaurant or conference rooms, but I would be opposed to any outside amplified sound permits. As President of the Board of the Freeport Homeowners' Association I am writing this letter to express our opposition of the Final Development Plan and Design Review - New Five Story 172-Room Hotel and 8000 Sq. Ft. Restaurant with Coffee Shop, located at the Esplanade site.

We are requesting more time to have a dialogue with the planning board to express our concerns. The community of Harbor Bay Isle was only made aware of the proposal a couple of weeks ago and many of our neighbors were made aware of the proposal a few days ago. To have the matter considered right after a holiday, not even a month after most of the neighbors were made aware of the development, is not fair to the neighborhoods. As neighbors we have not been NIMBYs. We worked with Joe Earnst of SRM Ernst when he first developed the Esplanade plan. We worked with him to mitigate the negative impacts on our neighborhood. We did not as a community oppose the original project. When a retirement home was proposed, we also as a community did not oppose the project but wanted certain mitigations written down and made part of the proposal. This hotel project, however, is different. We believe this project will have a greater impact on our quality of life due to increased traffic, noise and public safety concerns. We also believe the project will have a negative impact on our property values. This is evidenced by neighbors that have been unable to sell their homes because potential buyers are being made aware of a hotel being built right next door to a residential neighborhood. We did not have this problem when it was revealed that an office building could be built right next to our neighborhood.

We recently had a community meeting where we invited the developer to present the plan. When he asked if anyone was in favor of a hotel on this site, <u>no one raised their hand</u> in support. There were about 60 homeowners present at the meeting. Regardless of what was being built on the site that did not conform to the original Esplanade plan, be it an office building or a hotel, we would want more time to review the proposed project and how we could work with the developer to mitigate the negative impacts on our neighborhoods. This hotel is a radical departure from the plan presented to us for the Esplanade and deserves a thorough review and discussion with the Planning Board and developer so that we as a community can make an informed decision that benefits all parties involved.
