DECLARING CANVASS OF RETURNS AND RESULTS OF CONSOLIDATED GENERAL MUNICIPAL ELECTION HELD ON TUESDAY, NOVEMBER 6, 2018, INCLUDING ENACTING ORDINANCE NO. 3231 N.S. AMENDING THE ALAMEDA MUNICIPAL CODE BY ADDING SECTION 3-63 (TRANSACTION AND USE TAX) TO DIVISION IX (TAXES) OF ARTICLE II (TAXATION) OF CHAPTER III (FINANCE AND TAXATION) IMPOSING A TRANSACTIONS AND USE TAX TO BE ADMINISTERED BY THE CALIFORNIA DEPARTMENT OF TAX AND FEE ADMINISTRATION

WHEREAS, a consolidated General Municipal Election, under and pursuant to the provisions of Article XIX of the Charter of said City, was held for the purpose of electing officers to the Office of Mayor and Office of Councilmember, and for the purpose of submitting to the qualified electors of the City of Alameda certain proposals, as set forth hereafter:

One (1) Mayor of said City for a full term.

Two (2) Councilmembers on the Council of said City for full terms.

MEASURE F

City of Alameda Essential Services Protection Measure. Shall the measure maintaining the City of Alameda's financial stability and protecting services and infrastructure such as police response to violent crimes and burglaries; 9-1-1 emergency medical and fire response; maintaining neighborhood parks; repairing potholes, maintaining streets and protecting the Bay from pollution by enacting a 0.5% sales tax until repealed by voters, providing approximately \$5,000,000 annually in locally controlled revenues, requiring independent audits and public spending review, be adopted?

MEASURE K

City of Alameda Initiative Measure: Shall the Charter be amended by incorporating Ordinance 3148, the City's Rent Review, Rent Stabilization and Limitations on Evictions law, with the following modifications: (a) preclude City Council from amending the law in response to changing conditions and concerns, and require voter approval instead, and (b) eliminate the December 31, 2019 sunset clause?

WHEREAS, notice of the election was given in the time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and

declared in the time, form and manner as required by the provisions of the City Charter; and

WHEREAS, the City Clerk has received the canvass of returns of the election and has certified the results to the City Council, the results are received, attached and made a part hereof, as "Exhibit A."

NOW, THEREFORE, BE IT RESOLVED, DETERMINED AND DECLARED BY THE COUNCIL OF THE CITY OF ALAMEDA and said Council finds, as follows:

(1) That said Consolidated General Municipal Election was held and conducted, and the votes cast thereat received and canvassed, and the returns thereof ascertained, determined and declared in all respects and particulars in the time, form and manner provided by law.

(2) That the whole number of ballots cast in the City of Alameda at said election was 35,727 and the total number of registered voters at said election was 48,512.

(3) That the name and total number of votes cast in the City of Alameda at said election for the office of Mayor of said City was as follows:

NOW, THEREFORE, BE IT FURTHER RESOLVED, DETERMINED AND DECLARED that the aforesaid Marilyn Ezzy Ashcraft, having received the highest number of votes cast for the Office of Mayor, was, and is hereby declared to be, duly and regularly elected to the Office of Mayor of the City of Alameda, for a term beginning at 8:00 o'clock p.m., on the third Tuesday in December, 2018, and continuing for four (4) years thereafter and until a successor is elected and qualified, and

(4) That the names and total number of votes cast in the City of Alameda at said election for the Office of Councilmember of said City was as follows:

John Knox White	14,203

Jim Oddie	10,576

NOW, THEREFORE, BE IT FURTHER RESOLVED, DETERMINED AND DECLARED that the aforesaid John Knox White and Tony Daysog having received the two highest number of votes cast for the Office of Councilmember, were, and are hereby declared to be, duly and regularly elected to the Office of

Councilmember of the City of Alameda, for a term beginning at 8:00 o'clock p.m., on the third Tuesday in December, 2018, and continuing for four (4) years thereafter and until a successor is elected and qualified; and

NOW, THEREFORE, BE IT FURTHER RESOLVED, DETERMINED AND DECLARED that the aforesaid Jim Oddie having received the third highest number of votes cast for the Office of Councilmember from at least ten percent (10%) of the total number of voters, was, and is hereby declared to fill the Office of Councilmember vacancy caused by the election of Councilmember Marilyn Ezzy Ashcraft to the Office of Mayor, for a term beginning at 8:00 o'clock p.m., on the third Tuesday in December, 2018, and continuing for two (2) years thereafter and until a successor is elected and qualified; and

(5) That the total number of votes cast in the City of Alameda at said election for the aforesaid Measure F was as follows:

BE IT FURTHER RESOLVED AND DECLARED that the aforementioned Measure F, having received a majority of the number of yes votes cast was and is declared passed; and

(6) That the total number of votes cast in the City of Alameda at said election for the aforesaid Measure K was as follows:

BE IT FURTHER RESOLVED AND DECLARED that the aforementioned Measure K, not having received a majority of the number of yes votes cast was and is declared not passed.
