Comments

• Ashcraft - what is happening with the STC?

WETA Ridership Survey Data

- Ortiz WETA should update their numbers in the ACTC Performance Report
- Hursh what is the ridership? 11,000 boardings/day
- Peeples is capacity mandated by the coast guard and available life jackets? Correct.
- Elsa what do you do when there is overcapacity? Try to run more service, but there are fleet limitations. 80% is the goal for capacity and prompts making service changes, but there are resource constraints systemwide
- Eshleman what is the operating budget today? \$47 million/year and RM3 provides an additional \$35 million/year
- Vessel shortage on weekday but not on weekend
- Elsa farebox recovery is 74%. How does that help you? MTC requirement is 40%. There is an MTC concern that fares are too high and the WETA board wants to lower the farebox recovery for more equity. 25% of operating budget is subsidy, mainly bridge tolls
- Kevin RM3 will allow for more weekend frequency when there is available vessel capacity, but not Harbor Bay service. Go from hourly to half hour and later, until 11pm
- Opening of Sea Plan will change service dramatically in Alameda 30 minutes from Sea Plan on top of the service to Main Street to the SF via Oakland
- Peeples is 2021 realistic for starting Treasure Island service? Kevin we are operating on TIMMA's schedule which is ambitious
- Elsa how will you reduce parking demand at seaplane? Gail only 400 parking spaces at Seaplane, so that alternate modes are used
- Peeples is the roadway to Main Street ferry ok? Del Rosario it is better now. Thomas need to better control the parking land around Main Street Ferry. It is not managed and is free. Seaplane will open in 2020 and there will be a charge for parking. Next will be to focus on Main Street.
- Ortiz always request for service to Main Street ferry
 - Ashcraft single-occupancy drivers is down and she would like to charge sooner. What would it take for AC Transit to operate bus service to the ferry? Road conditions in the free parking is in poor condition
 - Ortiz staff will discuss with Alameda
 - Andrew Thomas already having the discussions and determining how much money can the charge for parking generate?
 - Shotmaier permit parking fees did not impact ferry ridership

- Kevin this is correct at Harbor Bay. Ridership increased on ferry but the bus ridership did not increase
 - Peeples is the walking data accurate if they didn't necessarily walk from home? It is possible.
- Kevin we should plan for seaplane since the switch over will happen in 14 months
 - Andrew development is at Seaplane and EasyPass
 - Peeples is there EasyPass for ferry? Not yet
- o Gallo need to orient the public to adapt to transit at seaplane
- o Walk Alameda why not start the Main Street ferry sooner
 - Gail potential pilot under alameda shuttle
 - Thomas no resources right now
- o Robert need to make decisions and we are short on resources. We will review.
- Kevin demographics ridership skew a bit younger and higher income distribution, mainly because of Harbor Bay residents, who are walking and not taking transit
 - Thomas likelihood of bus ridership is low at harbor bay because of walkshed. Main Street is more conducive to transit ridership
- Ortiz need to have dedicated lane on the bay bridge to improve viability. Ferry is maintaining speed and becoming more popular as a result
- Kevin developing an app to sell fares for the recreational riders.
 - o Complaints about clipper accessibility (No TVMs or AVMs) has resulted in the app

Line 19/96

- Ortiz summarized the public comments heard at the public hearing and concern of the visually impaired in Marina Village
- Chris how much longer is the trip from Buena vista 3 minutes but can be absorbed in the existing schedule
- Andrew Thomas there are tradeoffs but line 19 will serve another shopping center which was a short-coming of the service as it is operated today.
- Mike Hursh scheduled to go to the board tonight
- Elsa asked staff to act quickly for the December implementation
- John should I plan to make public comment?

AC Transit service hours

- Elsa to be clear, AC Transit is spending more money on service than the revenues coming in
- Thomas C1 is easy to show residents. The perception is that property tax can be pulled from AC Transit to run their own shuttle, but there are many more subsidies that we provide outside of C1 and C1 on its own could many sustain only one route.
- Maria Gallo appreciate the data compared to perception. In the big picture, this confirms that what else is possible to get on and off the island?

o Ashcraft - point well taken, but free shuttle concept may not

AC Transit ridership data and customer feedback data

• Mike Hursh - August issues due to significant projects, start of school, paired with hiring issue in a strong economy, resulted in operational challenges in August, but they have improved through October

New AVL Update

- Mike Hursh rolling out in D4 and should be complete before the end of the year
- John does the new data translate directly to the information in the kiosks? MIke yes.
- Peeples polling is better
- Hursh communications is better switching from radio to cellular

Transbay Tomorrow

- Hursh Fremont will open tomorrow, but we do not know when bus service will start again. Independent inspection responsibilities has been handed over to MTC, which is good but will delay the process. First Street has been added to the schedule of repairs because construction is similar to Fremont.
- Peeples need to guarantee the facility is safe before we move in. Temp terminal facility really helped us
- Ashcraft how is temp terminal operations? Hursh slightly delayed but similar to previous operations.
- Eric previous TC member, recalled the OX local ridership from years ago. Disappointed that local ridership is no longer allowed as of August.
- Linda discussed outreach and guiding principles
- Eric severe cuts in service; doesn't make sense

RM3/SB1

- Ortiz how can we spend money with the lawsuit?
 - Kevin can't bond when there is a lawsuit, but operating can proceed
- Peeples SB1 is close, but dollars in the campaign favor not repealing Prop 6
