The EEOC and many federal courts have recognized that anti-LGBTQ discrimination is a form of sex discrimination. The Supreme Court will now decide whether to revoke or affirm these non-discrimination protections. The Council has voted to authorize the City Attorney to sign in favor of recognizing and affirming that anti-LGBTQ discrimination is a form of sex discrimination.
