RE: Support for Climate Action and Resiliency Plan – Item 6-B on the September 3, 2019 Regular Meeting of the City Council

Community Action for a Sustainable Alameda (CASA) strongly supports adoption of the Mitigated Negative Declaration, Mitigation Monitoring and Reporting Program, and Climate Action and Resiliency Plan, full funding and staffing of the plan, and early implementation of the plan elements.

The plan that is before you includes many of CASA's priority initiatives. As the City moves forward to implement and update the plan, we would like to see more efforts in the following areas.

- Phased in electrification for all new development (including multifamily and commercial development) and future consideration of electrification requirements for existing buildings (at the time of sale or major remodel) – to be addressed in a future ordinance.
- Transportation mode-shift away from single use occupancy vehicles and more emphasis on making Alameda safe for biking and walking – to be addressed in the Active Transportation Plan.
- Investment in the urban forest, including not only street trees, but also forest groves in Alameda's parks, at schools and on private property – to be addressed in the Master Street Tree Plan.
- Dedicated staffing for Climate and Resiliency in her research about what made the early climate action plans successful, Professor Adrienne Greve at Cal Poly - San Luis

Obispo found that the presence of a sustainability/climate coordinator positively correlated with success.¹

To further support these initiatives, CASA will actively participate in the planning process for the development of the Active Transportation Plan and the Master Street Tree Plan. We will also participate in the public process for the development of the electrification ordinance and closely monitor City budgets and staff support for implementing the plan elements.

CASA members will be in attendance at the City Council meeting on Tuesday, September 3, 2019, but most of us will not plan to put in speaker cards (unless there is concern expressed by the City Council or public). Please know that CASA is in full support of the recommended action and Alameda has a broad constituency in support of mitigating the risk of climate change and preparing for the impacts of sea level rise.

We look forward to continuing a partnership with the City in its efforts to meet the goals of the plan.

Dear Mr. Thomas:

East Bay Municipal Utility District (EBMUD) appreciates the opportunity to comment on the Mitigated Negative Declaration (MND) for the Climate Action and Resiliency Plan located in the City of Alameda (City). EBMUD commented on the Notice of Public Hearing for the Climate Action and Resiliency Plan and MND for the project on July 1, 2019. EBMUD's original comments (see below) still apply.

GENERAL

EBMUD owns and operates multiple rights-of-way (R/W) within the proposed climate change adaptation strategy projects areas. The attached EBMUD Distribution Map (1485B474) highlights R/W's near the Webster Tube and Posey Tube and climate change adaptation strategy projects (p.44 of MND). R/W 647 is a 10-foot easement that provides access to the 24-inch pipeline that delivers water to the City. R/W 4696 and R/W 4697 are 25-foot easements that provide access to interceptors for wastewater collection. The integrity of this infrastructure needs to be maintained at all times. Any proposed construction activity in EBMUD rights-of-way would be subject to the terms and conditions determined by EBMUD including relocation of the infrastructure and/or rights-of-way at the project sponsor's expense.

Alameda Climate Action and Resiliency Plan – Initial Study & Mitigated Negative Declaration (IS/MND)

Dear Andrew Thomas:

Thank you for including the California Department of Transportation (Caltrans) in the environmental review process for the Alameda Climate Action and Resiliency Plan. In tandem with the Metropolitan Transportation Commission's (MTC) Sustainable Communities Strategy (SCS), Caltrans' mission signals our agency's approach to evaluate and mitigate impacts to the State Transportation Network (STN). Caltrans' *Strategic Management Plan 2015-2020* aims to reduce Vehicle Miles Traveled (VMT) consistent with the State's goals and targets. Our comments are based on the June 2019 IS/MND.

Project Understanding

The City of Alameda (City) is proposing its Climate Action and Resiliency Plan (CARP), which provides a roadmap for the City to follow in reducing the City's greenhouse gas (GHG) emissions and assist California in meeting the GHG reduction goals established by AB 32 and SB 32. Also, the CARP intends to help the City address the growing threats posed by climate change.

Cultural Resources

The Posey Tube is eligible for the National Register of Historic Places and, as such, should be discussed as a cultural resource. Further, any project activities

physically touching or near the resource should be discussed in the cultural resource section of this environmental document or any future documents that propose work to the Posey Tube.

Lead Agency

As the Lead Agency, the City of Alameda is responsible for all project mitigation, including any needed improvements to the STN. The project's fair share contribution, financing, scheduling, implementation responsibilities and lead agency monitoring should be fully discussed for all proposed mitigation measures.

Encroachment Permit

Please be advised that any work or traffic control that encroaches onto the State right-of-way (ROW) requires an encroachment permit that is issued by Caltrans. To obtain an encroachment permit, a completed encroachment permit application, environmental documentation, and six (6) sets of plans clearly indicating the State ROW, and six (6) copies of signed and stamped traffic control plans must be submitted to: Office of Encroachment Permits, California DOT, District 4, P.O. Box 23660, Oakland, CA 94623-0660. To download the permit application and obtain more information, visit https://dot.ca.gov/programs/traffic-operations/ep/applications.
