I appreciate the District Attorney's encouragement to "consider the public interest, open governance and transparency" in any discussion and potential action, it is regular baseline that I use for decision-making and why I actively engage in discussions about local issues with people from all points of view. The DA's office may have been able to make that determination itself. However, by returning the tape to the City the decision now falls squarely on the City alone, along with any of the potential risks associated with taking the DA's Office's recommended actions.

As you can imagine, with threats of lawsuits, etc. related to the entire Keimach issue, the issues she raises are three important considerations, but they are not the only considerations in looking out for what is best for the city (as can be seen in the DA's solution to avoid the issue herself).



Dear City Council and City Clerk:

Our country faces an *acute* crisis of honesty and openness in government. The president's modus operandi is to lie, conceal, and threaten to sue and discredit the people and institutions that seek the truth. It seems all the *worse* because his methods may succeed and become the modus operandi for politicians of all stripes and parties into the future.

Elements of the nation's affliction are being played out in our City Manager scandal *that the Council has still not resolved*. Lying: either a councilmember or a *respected Police Chief*; either a councilmember or an *audio recording*; either a councilmember or the *Alameda County District Attorney*; either a councilmember or the *Alameda County Grand Jury*. Concealment, discrediting and threats to sue: instead of calling for release of the audio recording, there are veiled and open threats of legal action against the City, and an attempt to discredit the Alameda County Grand Jury. Now that the District Attorney has opined that release of the recording would be in the public interest, are attacks on the District Attorney next?

It all reads like a children's version of the Trump playbook.

And what to tell *our* kids? That the Trump way works? "Fight back - be brutal, be tough - don't take it. It is always important to WIN!"? That if you have done something wrong, hire the best lawyers and consultants to try to cover it up and shift blame; attack your accusers' true statements; threaten frivolous legal action against the city *instead of acting as its steward*? Is this different from Trump lying and then telling us to "get over it" while sticking us with the tab?

That is not the way it should be. Alameda's city government is not here to benefit individual councilmembers, or their careers, and Alamedans should not be told to just "get over it".

Alameda can provide leadership on the housing crisis, renter protections, environmental policy, protection of immigrants, great schools, promotion of sustainable modes of transportation, and more. Lying, concealment, discrediting of institutions that serve the public, and placing personal above public interests advance none of those goals and tarnish our city's reputation.

Most often, compromise in politics is a virtue. This is not one of those times. Please take a principled stand.

The Council should reject the frivolous claim against the city. Insurance companies pay small amounts to settle frivolous claims because it is cheaper than paying lawyers to fight. This case is different because the claim is being made by a councilmember who was elected to *protect the city's interests*. Paying money on a frivolous claim *to a councilmember* should not be considered just another "cost of doing business", and would undermine Alamedans' confidence in city leadership at a time when *confidence is needed* as Alameda heads towards important votes,

including to obtain needed funding for our schools and on possible changes to the City Charter. If the councilmember chooses to proceed with a lawsuit against the city, so be it. The blame would lie with the councilmember and not the City Council as a whole.

Next, release the audio recording. The Grand Jury's partial disclosure of the contents of the recording was attacked – with the rest of its report – as misleading, selective, and biased. The *best answer* to those councilmember-led attacks on the integrity of the *Alameda County Grand Jury* is to let the public *who have paid for all of this* hear the recording and judge for itself. A decision by the Council to *trust the Alameda public* to make those judgments would go some way to *finally* putting this mess behind us and keeping the culture of dishonesty at bay.

No one has a silver bullet to cure the nation's or this city's ills, but if the Council has any doubt about how to proceed, it should err on the side of the truth.


