Thank you for considering this letter in lieu of my attendance at the City Council meeting scheduled for [11/19/19](#). As a 22 year Alameda resident, who has spent the last 11 years living adjacent to a bar that has been illegally using the outdoor area as a drinking, smoking and partying area for belligerently drunk patrons, I'd like to offer my support for Council Member, Malia Vella's council referral intended to increase code enforcement. Over the past decade, I have made numerous attempts to report code violations related to the noise, nuisance, unsafe, and illegal actions and behaviors of The Club House Bar and their patrons. Unfortunately, these reports (to Code Enforcement, APD, and The ABC) have not been given the responsiveness needed to enforce the laws with this bar or their patrons. This lack of responsiveness has allowed this bar and their patrons to continue to blatantly ignore the laws for years and years. I believe that Ms. Vella's council referral to transition building inspections into a new unit for universal code enforcement will significantly increase the City's ability to enforce existing laws in a timely and effective manner. Ms. Vella's plan will allow Alameda citizens better access to code enforcers and may result in a higher likelihood that the reported issues are remedied sufficiently.
