Memorandum of Agreement (MOA) Regarding the Exchange and Cooperation between Alameda, California, the United States of America and the County of Yeongdong, the Republic of Korea

The County of Yeongdong, the Republic of Korea and the City of Alameda, California, the United States of America (hereinafter referred to as "the Parties") have signed the Memorandum of Agreement (MOA) on the formation of the official relationship of Sister Cities based on the principle of equality and mutual benefit, common development, and enhancement of the Memorandum of Understanding signed on July 3, 2017.

The following agreements are concluded in accordance with the laws of both countries, the treaties between the two countries and the principles of international law, with the aim of promoting mutual friendship visits, actively carrying out deep and wide friendship activities, and strengthening smooth cooperation relations.

Article 1 Purpose

The purpose of the MOA is to strengthen the mutual cooperation in carrying out the exchanges and cooperation between the Parties and in the implementation of the Friendship Exchange and Cooperation Program between the two jurisdictions.

Article 2 Cooperation Areas

The Parties shall encourage the governments, non-governmental organizations, enterprises, and residents or citizens of each country or city to carry out friendship exchanges and shall cooperate on the following matters:

- 1. Sharing of skills and experiences for promoting cooperation in administration, tourism, festivals, and cultural arts projects.
- 2. Promotion of regional development and activation of local economy utilizing regional characteristics and resources.
- 3. Sharing policy and technology information on the local agricultural products and wine industry in both regions.
- 4. Developing and implementing youth exchange programs for human resource development.
- 5. Cooperating on continuous improvement for the achievements of the Agreement.
- 6. Cooperating in other areas agreed by the Parties.

Article 3 Implementation

The Parties shall mutually implement the contents of the following subparagraphs in order to strengthen their cooperation:

- 1. Exchange important information and best practices in the areas of mutual interest.
- 2. Interact for mutual cooperation (holding workshops, seminars, etc.).
- 3. Exchange of and participation in cultural, tourism, festival, and other arts programs.
- 4. Consult and cooperate mutually on sales and development of agricultural products, such as wine.
- 5. Cooperate on joint activities, such as visits to educational institutions and research centers when exchanging college, junior high, and elementary school students.
- 6. Implement other terms agreed upon by the two cities.

Article 4 Organization of the Working Group

The Parties shall form a working group for the implementation and continuity of the provisions of this Agreement. The Parties shall keep regular contact and exchange information on matters of mutual interest.

Organization of the Working Group

- The Chairperson and/or Board Member of the Alameda Sister City Association (ASCA) Yeongdong Sister City Committee is designated as the representative of Alameda, California, USA.
- The head of the Yeongdong County Administrative and Welfare Bureau is designated as the representative of the County of Yeongdong, Chungcheongbuk-do, Republic of Korea.

The Working Group shall hold regular meetings, by live video, telephone, and when necessary, in person, at agreed upon time and place, as applicable, by the Parties to assess activities derived from the application of this Agreement and perform the following functions:

- 1. Make decisions necessary to fulfill the objectives of the Agreement.
- 2. Formulate and materialize specific projects.
- 3. Establish and implement recommendations in accordance with this Agreement.
- 4. Perform other functions agreed upon by the Parties.

Article 5 Cost

The expenses required for the implementation of the present MOA shall be reciprocal and shall be borne by each of the Party. This MOA shall not be construed or interpreted as a financial promise or obligation.

Article 6 General

- 1. The Parties shall mutually consult each other when used for purposes other than cooperation projects conducted based on the output arising from the implementation of the cooperation projects.
- 2. The Parties shall not disclose or provide any material or information acquired in the course of the implementation of this Agreement to any third party without the consent of the other party. This does not preclude ASCA from reporting confidential information to the City of

Alameda, as ASCA is an agent of the City of Alameda. This remains in effect even after the termination of the Agreement.

Article 7 Effect

This MOA shall be effective on the date of signatures and shall remain in effect until such time as it ends.

If either party wishes to revise or terminate the MOA, a six-month notice shall be given in writing.

Two copies of the authentic text of this MOA has been signed in both Korean and English in both the County of Yeongdong and the City of Alameda on ______, 2020, and each copy has the same effect.
