

Public Services Allocation Recommendations



On January 7, 2020, SSHRB presented the CDBG stakeholder input to the City Council that included the need to address, among others, affordable housing, fair housing, food security, homelessness services, and mental health. The SSHRB needs statement letter presented to Council also discussed the current status of services being provided to residents of Alameda, emerging issues that need attention, and possible gaps in services. This guided the Notification of Funding Availability for CDBG Public Services issued by the Alameda Housing Authority soliciting proposal from qualified providers to deliver services to residents of Alameda. SSHRB members reviewed the proposals and concurred with staff's recommendations on the allocation of CDBG Public Services funding to community service providers.

Below is a summary of the CDBG Public Services recommendations for funding with two-year agreements (FYs 2020-2021 & 2021-22).
