Our children have already been shown to be unsafe traveling along the West side of Island Drive, with the driveways into the shopping center being notoriously dangerous for children. Many use the East side of the street to avoid the traffic entering and exiting the shopping center. Even if a round-about is installed at this intersection, it will still be plagued by high concentration of traffic moving through the cicle. This "hot spot" will cause further backup and bottlenecking such that people may redirect to go past the Earhart school and further burden the slow traffic movement during the morning hours.

There should be a "plan B" alternate. That alternate could be located on the edge of the HBI Business Park such that there is plenty of clearance for traffic flow to exit and enter from a drive-through located within an existing parking area. Further, given the history of the Business Park, with respect to the frequent high unoccupancy rates over the past 30 years, it would benefit from this located in that area as an incentive for further businesses to locate (post pandemic) into the park following the inevitable vacancies as businesses there exit the market.

I hope that you and yours are well during this time.

I would like to speak up to the Board and ask that a Starbucks not be allowed to come to Harbor Bay Isle, across from the shopping center; I strongly oppose it.

The current owner of Coffee & Tea Traders (I worked there from 1991-1998 also for a different sole proprietor) is a minority woman who absolutely will be negatively impacted if a franchise chain were to be constructed across the street to compete with her.

Further, Harbor Bay Isle is a mostly residential area, and the commute traffic to the ferry, morning and evening, has caused speeding down Mecartney and the lack of following traffic laws at this four-way stop (Mecarteny and Island Drive). Dear Planning Board members,

Bike Walk Alameda requests that you not approve the Use Permit to allow extended hours of operation for a proposed drive-through café and use of a patio for outdoor dining. Bike Walk Alameda has no issue with either the use of the patio for outdoor dining, or their expanding their business hours; However, we have very strong reservations about the approval, and extension of drive-through hours.

In the US, 75% of the vehicle collisions that result in a pedestrian death occur at night. In every City plan and document from the Active Transportation Plan to the Climate Action and Resiliency Plan (CARP) to the updates being made to our General Plan, we have objectives to make *walking and biking safer*, and to encourage mode shift away from single occupancy vehicles. Extending these hours from the original use permit is in direct conflict with those objectives. It will result in increased traffic just when kids are trying to get to school and for most of the year, it will be dark, or worse, it will be around sunrise. Having the drive thru operating while kids are walking and biking to school increases the number of dangerous conflicts at an already treacherous intersection.

The proposed use permit for extended hours increases the impact of the drive through by having it used during pre-dawn and evening hours, shining headlights into homes on the adjacent street in a fashion never envisioned by the previous bank's Use Permit.

In addition to *not approving this Use Permit*, we ask that this board delay any Use Permit decision for the drive through until staff can bring a report back on the *original* drive through Use Permit to the Board. Specifically, there should be a use permit and/or design review resolution describing the previous use for this board to review. I would assume that the original Use Permit only allows the drive through to operate during bankers hours. That original Use Permit is revocable by this Board, if you can make the necessary findings. Consistent with all of our plans and documents, this board should be working towards *reducing the number of drive-throughs* in our community, not increasing their hours.

We respectfully ask that the Board review options so that the project will be consistent with current City policies and stated goals of reducing drive trips and increasing the safety for pedestrians.

We would also like the board to direct staff to ensure that the **minimum bike parking requirements** are met as part of this project. There have been several recent examples where retail construction permits have been closed without meeting those minimum requirements. When brought to staff's attention after the fact, we've been told that nothing can be done, as the permit has closed. We don't want to miss this opportunity to fix this again. Most recently, this happened with the construction on Lucky's facade at Marina Village. We're not sure where in the process bike parking minimums need to be added to the plans, reviewed, and approved prior to close of permit, but all of those steps are being missed. Please provide direction to staff to identify where this should take place prior to issuing any permits for this project.

Thank you for your time and consideration of Bike Walk Alameda's concerns with this Use Permit.
