

CITY OF ALAMEDA RESOLUTION NO. _____

DECLARING CANVASS OF RETURNS AND RESULTS OF
CONSOLIDATED GENERAL MUNICIPAL ELECTION HELD ON
TUESDAY, NOVEMBER 3, 2020

WHEREAS, a consolidated General Municipal Election, under and pursuant to the provisions of Article XIX of the Charter of said City, was held for the purpose of electing officers to the Office of Councilmember, the Office of City Auditor and the Office of City Treasurer, and for the purpose of submitting to the qualified electors of the City of Alameda certain proposals, as set forth hereafter:

Two (2) Councilmembers on the Council of said City for full terms.

One (1) City Auditor of said City for a full term.

One (1) City Treasurer of said City for a full term.

MEASURE Z

Proposed Ballot Measure of the City of Alameda. Shall the measure amending the City Charter to repeal the prohibition against the building of multi-family housing in Alameda and amending the City Charter and the General Plan to repeal the citywide density limitation of one housing unit per 2,000 square feet of land be adopted?

MEASURE AA

Proposed Ballot Measure of the City of Alameda. Shall the measure amending the City Charter to clarify the prohibition against members of the City Council interfering with City Manager's duties, authorize the City Attorney to prosecute State law misdemeanors, and amend outdated provisions, including utilizing gender neutral language, be adopted? Such amendments will be accomplished by amending Charter Sections 2-9, 2-16, 7-3, 8-2, 10-2, 10-3, 10-4, 10-4.1, and deleting Sections 2-15, 22-7, 22-8, as set forth in City Council Resolution No. 15673.

WHEREAS, notice of the election was given in the time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in the time, form and manner as required by the provisions of the City Charter; and

WHEREAS, the City Clerk has received the canvass of returns of the election and has certified the results to the City Council, the results are received, attached

and made a part hereof, as “Exhibit A.”

NOW, THEREFORE, BE IT RESOLVED, DETERMINED AND DECLARED BY THE COUNCIL OF THE CITY OF ALAMEDA and said Council finds, as follows:

(1) That said Consolidated General Municipal Election was held and conducted, and the votes cast thereat received and canvassed, and the returns thereof ascertained, determined and declared in all respects and particulars in the time, form and manner provided by law.

(2) That the whole number of ballots cast in the City of Alameda at said election was 44,665 and the total number of registered voters at said election was 52,357.

(3) That the name and total number of votes cast in the City of Alameda at said election for the Office of Councilmember of said City was as follows:

(4) That the names and total number of votes cast in the City of Alameda at said election for the Office of City Auditor of said City was as follows:

NOW, THEREFORE, BE IT FURTHER RESOLVED, DETERMINED AND DECLARED that the aforesaid Kevin Kennedy having received the highest number of votes cast for the Office of City Treasurer, are, and is hereby declared to be, duly and regularly elected to the Office of City Treasurer of the City of Alameda, for a term beginning at 8:00 o'clock p.m., on the third Tuesday in December, 2020, and continuing for four (4) years thereafter and until a successor is elected and qualified; and

(6) That the total number of votes cast in the City of Alameda at said election for the aforesaid Measure Z was as follows:
