On January 27, 2021, the Transportation Commission will host a presentation on round-abouts throughout Alameda. My first question is "Why?" Many intersections have lights, stop signs or flashing lights which serve as a warning to drivers to slow down. One of the intersections being considered for a round-about is Mecartney at Island Drive. This is a busy and wide intersection with a lot of automobiles, bicycles and pedestrians, including a 4-way boulevard stop.

I understand you are considering a Roundabout installation at the intersection of Mecartney and Island Drive on Bay Farm Island.

While Roundabouts may be alright for some intersections in Alameda, this intersection should not be changed: We have a lot of elderly persons using that intersection; also disabled and also many school children, considering the close by elementary school.

Additionally, particularly at commute times, the cars are moving very fast on both Island and Mecartney. Now, the stop signs stop the cars which is good as it gives the pedestrians an opportunity to cross safely. If a Roundabout is put in there, it seems only common sense, that it will increase the danger for pedestrians, as cars will moving fast, then slowing down(not stopping) and the drivers will be looking ahead to see how fast they can enter the roundabout.

I was shocked to hear that the City of Alameda is proposing a Roundabout at the intersection of Mecartney Road and Island Drive. In my hometown of Elk Grove, CA they have installed many of these Roundabouts in the newer developments and they are dangerous. I myself have seen many people almost get into a wreck in these intersections and my brother who lives there says there are many accidents within them. He has also stated that once vehicles pass through them they then speed up beyond the speed limit as a response to these intersections deterring their path of travel. My experience in them is that vehicles trying to enter them have a hard time getting into them with traffic quickly trying to get through them, and I have witnessed vehicles having to slam their breaks on because of other vehicles trying to enter losing their patience and not judging the distance of vehicles already in the roundabout. This is already a wide intersection with amble room for turning and continuing straight. In addition how would the fire trucks be able to maneuver these round about areas and respond quickly to calls? The only time of day that this intersection is busy is during commute times when the ferry is running at the Harbor Bay Terminal. In addition, pedestrians have a difficult time crossing the intersections with these type of roundabouts. In addition the stop signs currently at this intersection require traffic to be at a <u>complete stop</u> for pedestrians and cross traffic to proceed safely.
