CUSTOMER SATISFACTION SURVEY RESULTS

- ACI ranked #2 among local utilities @ 83% favorable view
- 89% of customers satisfied with recycling, organics, and garbage services
- 74% of customers believe cost of ACI's service is reasonable
- Satisfied customers cited reliability and good customer service
- Dissatisfied customers cited bin problems, misses, or cost of service

STAKEHOLDER & PEER REVIEW INPUT

- Maintain rate relationships and incentives for waste reduction/recycling
- Update bulky item collection and expand to better serve multi-family
- More dedicated customer assistance, especially for businesses and multi-family
- Long-term capacity assurances and pricing for organics processing
- Consider exclusivity of agreement related to recycling and construction material
- Incentives to ACI for meeting/exceeding diversion goals
- Expand options for textile collection and recycling
- Managing contamination in recycling/organics through outreach and operations

NEW AGREEMENT HIGHLIGHTS

Term:

- July 1, 2021 June 30, 2033 (12 years)
- Two 4-year extension options at City discretion
- 3-year extension option at ACI discretion (diversion goal achieved in 8/10 years)

Services & Features:


- Focus on SB 1383 compliance and Zero Waste success
- Expanded opportunities for challenging materials (textiles, cardboard, cooking oil)
- Restructured and expanded bulky item and abandoned waste collection program
- Greater investment in public education and customer technical assistance
- Investments in transition to electric powered fleet
- 89% Diversion Goal with incentives (contract extension) and monetary penalties
- New contract and performance management tools


