## ALAMEDA'S 2021 PROCLAMATION IN DEFENCE OF DEMOCRACY

**Whereas**: on January 6<sup>th</sup>, 2021 insurrectionists attacked the U.S. Capitol intent on stopping the constitutionally mandated certification of the official 2020 election results and thereby interrupt the peaceful transition of governmental power, and

Whereas: the FBI has determined anti-government, White Supremacist and racists militias to be the driving ideologies behind the organization and implementation of the attempted insurrection, and US national intelligence directors tell us the danger has not passed and the gravest threat to our country is domestic violent extremist; and

**Whereas:** domestic violent extremists are radicalized by the "big lie" promoted still by a former president, on social media and extremist right wing "news" outlets; and

**Whereas**: the national escalating conflict between democratic and authoritarian principles and ideologies is a conflict felt in the City of Alameda, on our streets, in our schools and in our "local" social media; Alameda like the nation as a whole is faced with a fundamental choice: democracy or autocracy. Therefore,

**BE IT RESOLVED:** The City of Alameda condemns in the strongest terms the insurrection of January 6<sup>th</sup> on our Nation's capital and the violent domestic extremism that caused it, and

**BE IT RESOLVED**: The City of Alameda pauses at this moment to re-affirm our commitment to the institutions, customs, and norms of democracy; that we are a nation under law, with the right to life, liberty, and the pursuit of happiness for all.
