Here are some suggestions I would like to recommend.

- 1. All vendors, staff and musician must park their vehicles in the Fireside parking lot.
- 2. The speakers for the music must be placed beside or in front of the stage. No other speakers should be allowed.
- 3. No music shall be played on Thursday what so ever!
- 4. The volume must be in relationship to the area being used which is approximately 36'wide by 70' long, not a large area.
- 5. The events can not exceed two days per week, either Friday and Saturday or Saturday and Sunday.

President and Members of the Planning Board and City Staff (and staff, please forward this to the Planning Board),

I'm writing to request that at your meeting July 12 you require significantly different conditions than staff has proposed before approving a temporary conditional use permit ("CUP") for the parking lot at 1435 Webster at the corner of Taylor Street and Webster Street.

The outdoor concerts happening there now are very loud. It's a bit like there's a big outdoor frat party happening at Taylor and Webster multiple times a week.

The CUP should allow no more than one event per week with amplified music, and only permit that on a Friday or Saturday. The CUP should specify within it the permitted decibel levels for these events. The CUP should also include more certain and prompt consequences for any violations of its terms, since the proposed provision that staff will schedule a meeting to consider consequences provides no specific timeline for that meeting and would allow violations of the CUP to continue indefinitely.

For your consideration, here are some additional thoughts and perspectives from a music and art lover/West End business supporter and patron/nearby resident:

The inadequate outreach about these loud outdoor concerts before they began and as they have continued was not and is not neighborly.

The material change in how this "Healing Garden" and outdoor eating space has been used feels to some here like a dishonest "bait and switch."

Many more months of multiple loud events every week in this location now that business life is largely open again (including indoors) is not necessary for the survival or recovery of any local businesses.

If approved as staff is proposing, the CUP would mean the City is imposing a wide range of significant negative externalities on many people and businesses in this area in order to benefit one or two specific entities. It feels like a sweetheart deal for those specific entities.

It is hard to believe that a CUP anything like this would be approved in or adjacent to a residential area anywhere in Alameda other than the West End.

I wonder about the disparity in SES status between those bearing the immediate cost and impact of the negative externalities here compared to the patrons of these concerts, e.g., people willing and able to pay \$30 for tickets for the shows scheduled for July 10 and 17.

As outlined above, I request the following:

1) The CUP should allow no more than one event per week with amplified music, and only permit that one event on a Friday or Saturday.

2) The CUP should specify within it the permitted decibel levels for outdoor events.

3) To ensure and incentivize strict compliance with the terms of the CUP, the CUP should provide that any violation of its terms shall result in its immediate termination, with an opportunity for a hearing to reverse that termination. If the Planning Board won't use that approach, there should be a tight timeline for a hearing such as within seven days of a violation.

Hope you are well - I noticed that a neighbor of mine has posted several of these signs along the block. I don't live on the 700 block of Taylor myself, but just around the corner on Page St so I see the signs while out and about (and am very familiar with the "complaints" they refer to).

I'm reaching out to add my perspective, that I strongly disagree with everything they've said. The outdoor music has been a wonderful addition to the area, whether I'm attending myself or just passing by seeing people having fun. It's always been at a reasonable volume, ends at a reasonable hour, and I do hope it continues even after outdoor events are no longer a necessity for health reasons. I'd even advocate for more of it, if there are other similar locations nearby to support such events (this is probably a long shot, but if we could occasionally swap the bands for house music DJs that would be even better...).

In terms of traffic and parking, I'm unsure exactly what this individual is referring to - I park on Taylor neardaily, and it has never taken more than 5 minutes to find a spot. I rarely drive down Webster directly but when I do the delays are minimal, and there are myriad ways of getting to the neighborhood otherwise. Regardless, I think if some additional traffic and parking challenges are the result of bringing more arts & culture to the West End, then I would fully support that trade-off.

In summation, I sincerely hope that the sentiment indicated on these signs - and potentially shared by our other neighbors - does not lead to the cessation of the many fun things Webster Street has to offer. They are part of why I love living here, and part of what causes friends and family to say "what a cool neighborhood you've got!" when they have the opportunity to visit.

I've seen kids and elder adults alike gardening and getting together at the picnic tables. We often meet friends there to avoid going into our house to help prevent the spread of illness.

I'm sure you know that small businesses are struggling and many have gone out of business, and we do our best to regularly support them. Bringing people in from outside the very local area is essential to keeping Alameda businesses alive and encouraging growth within our community.

I live with my fiancé (and two cats), and we were recently approached by a neighbor trying to gain signatures for a petition to end the Healing Garden Arts concert series and are concerned that a very vocal few are trying to take away something we see as not only enjoyable, but beneficial to the local business in and around Webster St. We have heard worries from the local business owners about the ability to continue their outdoor programs. So, I want to make sure our voices are heard as well.

I do want to mention that this person was willing to write any name down on her list, and was quite persistent in getting my partners name, so I am wary that she could have been writing in people who do not want to be listed, or may not even exist.

Some concerns she raised were:

Noise - The music only runs for about 4 hours on Friday and Saturday and ends at 8pm when it is still light out. We all live close together and noise is to be expected. I think a larger problem are the racing cars that speed down local streets on quiet days. A few hours a couple days a week of professional music is welcomed and appreciated! In this letter, I am writing to share my support of community spaces, like the Healing Garden. As a long time resident of the West End of Alameda (20 years), I frequent the shops and businesses in and around Webster Street frequently, including Fireside, the Farmer's Market, Main Street Supply, and others. One of the best things to emerge during COVID-19 was the Healing Garden. Spontaneously in the wake of George Floyd's murder and Black Lives Matter movement, artists began creating works of art in the parking lot next to Calafia taqueria. It was a beautiful expression, and from that the idea to create a larger space, and now filled with even more art and live music celebrations. What a beautiful addition to our community. I have been at this space almost weekly. I have gone to free events as well as one paid event. My child was chosen as an artist to participate in the Healing Garden and their art is there for all to see, experience and meditate upon, as is the beautiful art of others. It allowed her to smash ceilings and create art on a larger scale than ever before! I personally have witnessed community in action in this space. I went to a show where four women performed for I would say 200 people? It was for Pride and the band had a following. Everyone was kind and we danced and swung to the music. Then something magical happened. A young disabled boy who was there with two adult caretakers expressed his desire to dance! They hesitated at first, but with support from those around him, gave him space in the front to move. He got up and danced his heart out in a safe and loving space, We clapped for the boy and he beamed. This is a space where everybody belonged and healing was present. I once lived in rural California and I had never thought I could achieve that small town community feeling in a town the size of Alameda, but that dusky evening, we did. Please support outdoor public spaces with live music and events, like the businesses and non profits that came together for the Healing Garden. From what I understand, there may be some neighbors who are making complaints about the noise. Although it is important to take into consideration individual points of view and perspective, it is also important to weigh that in comparison to the collective good for the whole. We should make available a community based response, if necessary, such as mediation, to hear the concerns and try to mitigate. However, it is also important to understand with gentrification and growing density in the city, we can expect the same levels of privacy we may in other regions. It is important not to elevate and protect the interests of others, especially when they only reflect their personal interest or preferences. As a community that reflects a variety of cultures and expressions, live music, celebration, noise, gatherings, are a part of communal gatherings and allow us to express ourselves and come together in public spaces. It reminds me of the situation in West Oakland, when a new resident made a complaint to the police that the gospel singing at the church next door was "too loud" on Sunday mornings. Once I rented an apartment above a bar. It would be unreasonable to expect there to be no noise until after bar time. It should be the same for residential areas that are adjacent to businesses. With this in mind, please remember it is not unreasonable for a business to stay open and make noise (even with residential properties/rentals adjacent). We cannot continue to protect the interests of the few and abandon the greater good of the collective whole and community.

Subject:	[EXTERNAL] Comments on Taylor/Webster Interim Use Permit

I am writing to express my opposition to granting the Interim Permit for the expanded use of the Taylor and Webster lot.

The initial Special Event Permit was granted without any notification or consultation with the neighborhood and has resulted in a minor uprising by the neighbors of the lot due to the intolerable level of sound and the dramatically increased traffic during the live concerts. The comments submitted to the Planning Department for the Interim Permit should give you a good idea of the depth of the unhappiness and I hope you take the opportunity to read them.

The City Code mandates that use permits "will not cause any damage, hazard, nuisance or other detriment to persons or property in the vicinity," and the use must be "operationally harmonious with the community".

Clearly, the concert events on the lot do not meet this criteria as evidenced by neighbor's comments.

To the best of our knowledge, no one from the Planning Department or Planning Board has been present or contacted the neighbors during the events to experience the disturbance.

To be clear, the neighborhood has supported the Healing Garden's creation and improvement with the contribution of labor, money, and plantings. We were never advised that there would be regular loud musical events there until they were well underway. The organizers have made some unfortunately feeble attempts to dampen the sound but the results have not really achieved much.

The large influx of traffic into the neighborhood has also proven to create a parking problems where we already suffer. Many houses have no driveways and folks can be forced to park blocks from home at the end of a working day. This is not to mention the decreased security in parking so far from home when the catalytic converter pirates seem to roam freely.

The Interim Permit also allows a large increase in event attendance which will only serve to exacerbate all the problems listed above.

My understanding of the rationale for the Special Permit was that it would mitigate the effects of the pandemic on the local businesses. From what I can see, the benefits of the concerts accrue solely to the Fireside Lounge and Calafia. My contacts with other merchants indicate that they, in fact, suffer from the disappearance of parking for several hours during prime weekend opportunity.

I hope the Board will take the time to contact neighbors and merchants in the area before voting on this issue. I think you will find that the concert events do not meet the City Code criteria for an enhanced Use Permit. I would also urge a much more stringent enforcement of noise standards to ease the unhappiness of our community.

As one of our City Council members remarked, "Do you think this would be allowed in Fernside or Franklin Park?"

Planning Board Members Cisneros, Curtis, Hom, Rotherberg, Ruiz, Saheba and Teague:

On behalf of the West Alameda Business Association Board of Directors, please consider our request for approval of the Use Permit for the Taylor/Webster lot, 1435 Webster Street. Some background information:

Working with the property owner, WABA has used this lot for various purposes over the last several years to make Webster Street an inviting destination to shop, eat and just enjoy. He continues to be a solid partner approving of our efforts.

Working with the West End Arts District, WABA has incorporated into our Strategic Plan and Vision to become an Arts District for the same reason we have created events on said lot.

The Healing Garden was created in late May after the George Floyd incident that created concern that Webster Street would be a target for vandalism. We advised our merchants to "Board Up" their windows. They did, and some created beautiful artwork. After the scare of vandalism passed, we asked our merchants for their plywood, with or without artwork, to be re-purposed in a positive way. The Healing Garden became a place to reflect and find peace. We continue to update the local artwork and healing events.

The entertain piece was created to capture commerce for our merchants. Volunteer and financial resources were used to make this happen. Neighbors were contacted and over 45 signed our application. We were approved for the current Use Permit from the City of Alameda. On "Good Faith" we have contracted and are obligated to honor these contracts to entertainers per the approved application. This has become a great source of employment, over 25 people have paying jobs!

This was created with very positive reasons, no intent on harming our neighborhood. We submitted a joint (WABA/WEAD) statement of mitigation efforts that is in your package. One neighbor commented that through our efforts of creating this space, dumping and unlawful acts no longer are a problem. Merchants that have benefited from the events are hesitant to make comment as they fear loosing business from the some folks in the neighborhood.

I'm choosing not to detail the level of slander and harassment that has been inflicted on staff and volunteers. It's been painful to be a target on this negative campaign.
