The ACT Board strongly supports the termination of the legal notice contract with the Alameda Journal and awarding the contract to the Alameda Sun.

We are fully aware that the cost of placing legal notices in the Sun is higher than the Journal. However, the cost of legal notice publication is a very tiny item in the City budget. The Sun is the only truly local paper dedicated entirely to Alameda. It is a significant source of local news and opinion. It has always operated on a very slim budget and has almost miraculously continued publishing throughout the pandemic. Depriving the Sun of this source of revenue may place its continued existence at risk.

I was dismayed to read earlier this year that the Council had voted to award its newspaper advertising contract to the Alameda Journal after years of using our own hometown newspaper, the Alameda Sun. The Journal is owned by a New York-based investment capital company with no relationship to Alameda, and the Journal rarely has the same coverage as Alameda news and events as the Sun.
