- Pedestrian and Bicyclist safety;
- Traffic Congestion & First Responder Access;
- Noise, Trash, and Property Damage Associated
 - Impacts Residents and Businesses; and
- Environmental Impacts

Recommendation

- Restrict or Eliminate Use Permits Authorizing Large Scale Automobile-Oriented Car Events at Alameda Point;
- Implement Barrier Option 2 (Retain Existing Barricades and Add Barriers);
- Implement the West Hornet Fence Option; and
- Leave Parking Space Wheel Stops

Direction from City Council

June, 2021 – City Council referral pertaining to automobile-related events at Alameda Point

Background: Automobile-Oriented Events

Three Types:

- Permitted Special Events;
- Non-Permitted (Informal) Large Scale Events; and
- Individual, Reckless Driving "Events"

Completed

- City Permitted Automobile-Oriented Events
 - Planning Department and Planning Board Have Reduced the Number of Automobile-Oriented Event Permits Issued
- Unpermitted Automobile-Oriented Events
 - In August, Public Works and Police Department Took Steps to Minimize Attractiveness for Reckless Driving By Placing Structural Barriers
 - Alameda Point Skate Park (Exhibit 1)
 - > South Side of Building 5
 - Open Area Between Lookout Tower and Building 25
 - Between January 1 September 20, 2001, APD responded to 109 Reckless Driving Calls at Alameda Point

Options to Address Permitted Events

- Modify Existing Use Permits in the Future
 - o eg., Hornet Museum Use Permit
- Deny All or Most Automobile-Oriented Special Event Permits

Options to Address Non-Permitted Events

- Barrier Option 1 Retain Existing Barricades and Add Barriers South of Building 25 (Exhibit 2);
- Barrier Option 2 Retain Existing Barricades and Add Barriers to the South Parallel to the Shoreline (Exhibit 2);
- Barrier Option 3 Change Existing Barrier Layout to Allow Vehicle Access and Parking for Buildings 25 and 29 (Exhibit 2);

- Regulatory Option Municipal Code Amendment to Criminalize Street Racing and Reckless Driving Events
