As a concerned neighbor and parent, I'm requesting the city paint crosswalks on Buena Vista at the Chapin & Wood intersections. I walk my children to Maya Lin School nearly every day, crossing at Buena Vista and 8th. Buena Vista remains a cross-island thoroughfare with few traffic stops from Sherman to Constitution. Though we have a crosswalk at Buena Vista & 8th, I've had many cars refuse to stop for me and my children. Once, a car even swerved to avoid us as we were in the crosswalk!

At the intersection where Lincoln bears right onto Constitution, drivers refuse to look as they try to beat the light and get to the Posey Tube. By the time we approach the intersection, there's frequently a critical mass of parents and children waiting to cross. One morning last week, a driver turning onto 8th from Lincoln told a family with school-aged children that they were walking too slow. With the construction currently happening in the area, the route is even more dangerous.

Families move to Alameda for the community, the proximity to schools, and the ability to engage with both without a car. Please make it safe so we can enjoy getting our children to school without worrying about drivers who can't be bothered to pay attention.

Hi Gail,

We are still requesting that crosswalks be painted on the intersection of Chapin St, and Buena Vista, with blinking lights if possible. It is very hard to cross over safely as it is a busy street with cars zooming by at high speeds with no stop signs for a very long stretch. The visibility is low and pedestrians are almost invisible, or so it seems. Many children are trying to cross over from these blocks on their way to school at Maya Lin. I am worried that this is a tragedy waiting to happen.

Thank you for the plan you have conveyed after my previous comment to paint crosswalks on 9th St., this is a good first step. But as our family (and many others) lives on Chapin St. and need to cross over Buena Vista daily, this doesn't really address our concerns fully. Going down two blocks to 9th in order to cross the street is better than nothing but doesn't work well on bicycles and frankly is unpleasant because of the high traffic in the morning hours. We ride bicycles often and try to get to Pacific to ride safely with our children. Sometimes we are also trying to get to somewhere else that isn't the school! This goes for all the families on our blocks.

I would also like to highlight the fact that this really is also an equity issue as the blocks that do not have safe crossings include low income housing - on the bottom of Chapin and Eagle St. and are under-represented in these conversations. I don't claim to speak for them but these families may not have the time or resources to write letters themselves to the committee and join public meetings (I myself barely do). I've seen kids from these blocks that may not be able to be walked to school by their families crossing very unsafely with no supervision. Many are also riding around unsupervised on bikes and I am really worried they will be hit at that intersection. Please just paint a crosswalk, I don't even know why there aren't crosswalks here already and suspect equity is the underlying issue.

Again, a crosswalk is really the bare minimum. We would also like blinking lights to make it more safe. I think the city should make sure that pedestrians can cross over safely at all these intersections, especially when there are so many families with young children on these blocks. I know there have been many complaints on SeeClickFix on these crossings and I hope you are taking them seriously.

I will attend the meeting tomorrow again and hope this will be addressed. I'm really just asking for a crosswalk and blinkers on Chapin and Buena Vista, not any changes to the traffic such as a stop sign!
