MODIFYING THE EXECUTIVE MANAGEMENT EMPLOYEES (EXME)
SALARY SCHEDULE INCREASING THE SALARY RANGE OF THE
CITY CLERK POSITION BY 14.85%, EFFECTIVE JULY 12, 2026

WHEREAS, the Council of the City of Alameda selected Lara Weisiger to serve as the City Clerk for the City of Alameda effective October 15, 2001; and

WHEREAS, the City Council considered the recommendation of a City Council Subcommittee that reviewed the salary of City Clerk following the results of a total compensation survey; and

WHEREAS, the total compensation survey reflected that the City Clerk position was below market median; and

WHEREAS, there has been submitted to this Council a modification to the Executive Employees (EXME) Salary Schedule, included as Exhibit 1, which reflects a 14.85% salary range adjustment (to \$265,519) for the position of City Clerk plus the additional contractual base wage increase of 1% (to \$268,174) effective July 12, 2026; and

WHEREAS, the Council of the City of Alameda has fully examined said proposed schedule, and thereby finds and determines adoption of said document to be in the best interest of the City.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Alameda that said Council hereby approves and adopts said revisions to the EXME Salary Schedule effective July 12, 2026; and

BE IT FURTHER RESOLVED that the provisions of this Resolution shall supersede any other resolution in conflict herewith.
