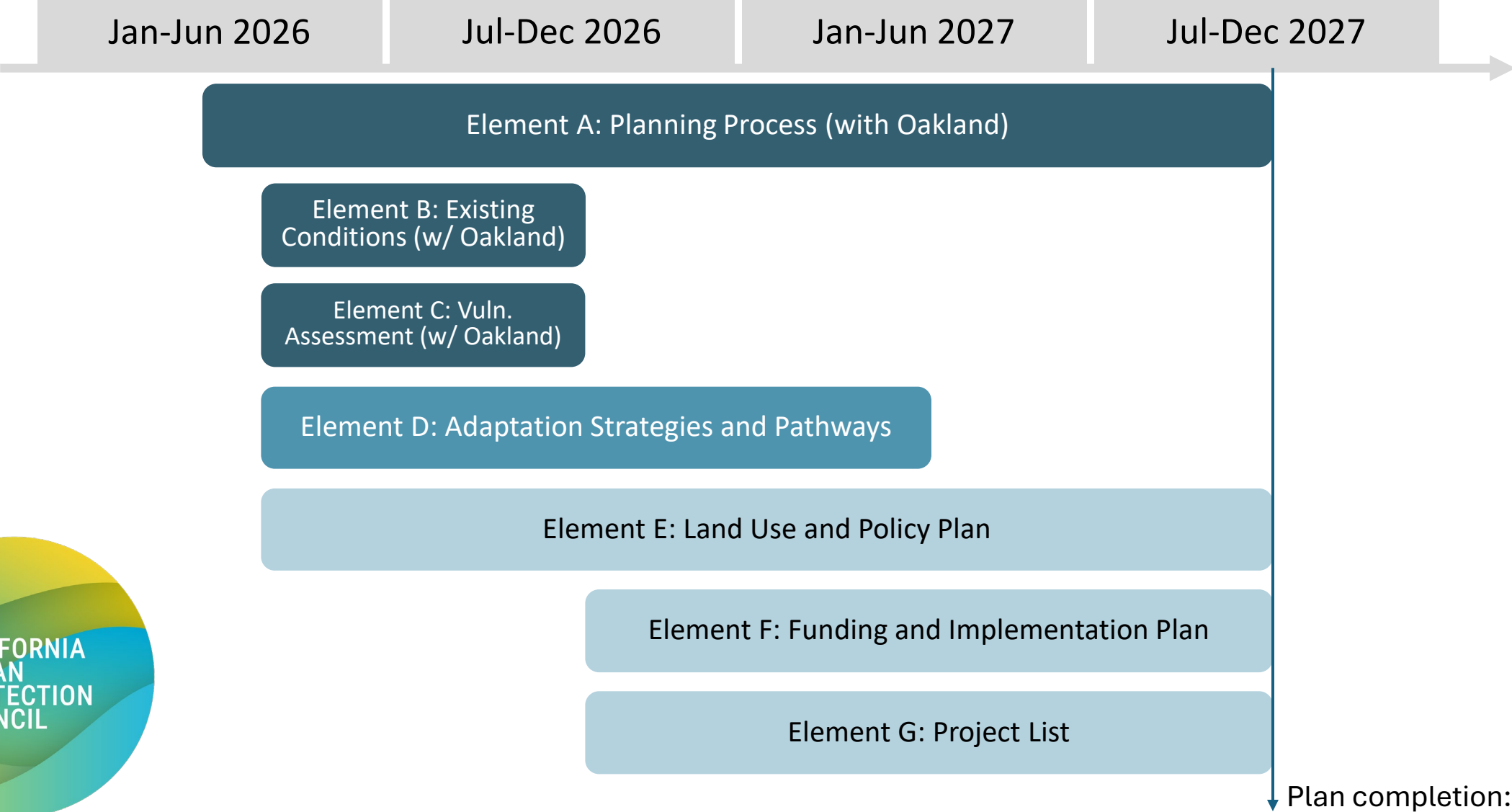
An implementing project of **BAY ADAPT**

- Phase 2 (April 2026-Dec 2027): SB1 grant funding
 - Build on the current plan and address gaps to achieve RSAP compliance
 - Refine strategy concepts and adaptation pathways
 - Policy/land use/funding plan
 - Community and stakeholder engagement

BFI Funding/Timeline

Purpose: Remove lagoon area of BFI from the FEMA 100-year floodplain, bolster the northern shoreline and Bay Trail from erosion, enhance shoreline habitat with nature-based solutions and enhance public recreation, including improvements to Bay Trail.

Phase	Description	Funding Source
Phase 1 (2023-2025)	30% design and community engagement	FEMA Pre-Disaster Mitigation Congressionally Directed Spending
Phase 2 (2025-2026)	30% design refinement, additional studies	Alameda General Fund
Phase 3 (2026-2028)	60% design & permitting, community engagement, Island Drive interim measure	State Coastal Conservancy Prop 68 (this agenda item)
Future Phases	Complete design and construction	Requires additional funding

Phase 3 Project Timeline

- Phase 3 – 60% design (Prop 68 funding)
 - May 2026: Project kick-off
 - Ongoing: community and stakeholder engagement
 - June 2027 (est.): Community workshop
 - Dec 2028: Project completion
- 2026-2027: Seek additional funds to complete design and construction
 - Seeking additional grants and other funding sources
 - Additional city funds will be required to complete project
- 2030: Target construction date



Staff Recommendation

- Accept Coastal Conservancy Prop 68 grant for \$2.6M to develop 60% design for BFI project
- Allocate \$50,000 from the General Fund for Public Works staff costs related to the project.
- Authorize amendments to agreements for BFI and Adaptation Plan:
 - CMG for technical consultant work
 - Greenbelt Alliance for community engagement
 - CASA for community engagement
 - SFEI for scientific review
